#### **CORRIGENDUM**

Approval of the Lieutenant-Governor is hereby conveyed for the modification of the conditions appearing in the Guidelines to G.O.Ms. No. 19/Ag., dated 26-02-2015 of the Chief Secretariat (Agriculture and Forests), Puducherry published in the Gazette of Puducherry, Part-II, No. 13, dated 6-3-2015 at Clause L,M,N of the Project (I) Project on increasing the yield of horticultural crops through "Precision Farming, Micro-Irrigation and Fertigation". Accordingly, the conditions shall be modified and read as follows:

No legal responsibility is accepted for the publication of advertisement regarding change of names and other private notifications in the Gazette. Persons notifying the same will remain solely responsible for the legal consequences and also for any other misrepresentations, etc.

#### L. Laying of micro-irrigation systems-

The PKKVK/PASIC, Puducherry, will be entrusted with the work of laying of micro-irrigation system in the individual farmers field. PKKVK/PASIC will call quotation from the reputed manufacturer/dealers of micro-irrigation system through e-tender for finalising the suppliers for laying micro-irrigation system by constituting their own Purchase Committee.

Alternatively, in case, if, PKKVK/PASIC is unable to carry out the laying of micro-irrigation system, the same can be done by constituting a Purchase Committee comprising of following Members, which will call quotation from the reputed manufacturers/dealers of micro-irrigation system through e-tender for finalising the suppliers for laying micro-irrigation system.

- 1. The Director of Agriculture . . Chairman
- 2. The Additional Director of Agriculture . . Member (T & V).
- The Additional Director of Agriculture . . Member (Karaikal).
- 4. The Joint Director (Agricultural . . Member Engineering).
- 5. The Junior Accounts Officer, ... Member (Agricultural Engineering/SGWU).
- 6. The Additional Director of . . Member-Agriculture (Horticulture). Secretary.

In addition, the following conditions shall be followed for laying of micro-irrigation system:

- (a) The manufacturer/dealer should be in a position to supply only Bureau of Indian Standard Certified (BIS) products.
- (b) The manufacturer should give material guarantee for a period of one year.
- (c) The survey will be conducted by concerned Agricultural Officer (Agricultural Engineering) in coordination with the successful tenderer for laying of micro-irrigation system and estimate prepared based on the rates approved by the Purchase Committee.
- (d) Estimate will be scrutinized by Engineering Wing and approved by the competent authority (Deputy Director, Soil Conservation) and unit cost will be approved by the Committee.
- (e) After approval of the estimate by the Deputy Director (Agricultural Engineering)/Joint Director (Agricultural Engineering)/Hydrogeologist-II, necessary work order will be issued to the farmers by the Deputy Director (Agricultural Engineering),

#### L Laying of micro-irrigation systems-

- (i) The implementation of the project will be done through the empanelled MI Contractors finalized through a competitive process. The Department will finalise cost/unit rate as per prescribed procedure and then the same will be published in print media and Departmental Website after obtaining due approval from the Government, for wide publicity and awareness of the stakeholders.
- (ii) Application with the required Annexure (viz., self attested copies of land document, registered lease deed for a period of 5 years for tenant cultivator, copy of the FMB sketch, Aadhaar Card, copy of Electricity Policy Card of tube well used for irrigation, Farmers Identity Card issued by the Department of Agriculture and Farmers Welfare, Puducherry/Revenue Certificate issued by the Revenue Officer not below the rank of Deputy Tahsildar and Affidavit by the beneficiary) will be received from the farmers. The farmers will also have option to choose any of the empanelled contractor/service provider and indicate it in their application Form. Directorate of Agriculture and Farmers Welfare will scrutinize the estimate as per the norms and recommend applications to this office and after being satisfied will issue work order for laying of the micro-irrigation systems to the empanelled micro-irrigation contractor/ supplier/manufacturer as per the choice of the farmer.

#### M. Distribution of critical inputs:-

For supply of other inputs *viz.*, seeds, planting materials, organic inputs, water soluble fertilizers, plant growth regulators, crop protectants, micronutrients *etc.*, as per the recommended level of concerned crops-beneficiaries have to make own arrangements for procurement of the abovesaid items from the reputed firms and the eligible subsidy will be released to beneficiary to the maximum of ₹ 60,000/ ha. including Goods and Services Tax on production of original bills to the Office of the Additional Director of Agriculture (Horticulture) as back ended input subsidy under DBT mode.

### N. Release of fund to the micro-irrigation contractor/manufacturer/supplier/dealers:

(i) On intimation of the completion of the work and receipt of bill of cost from the said contractor, joint inspection will be carried out by the officials of Horticulture, Agricultural Engineering and T&V.

Soil Conservation, based on the selection/approved list by the Office of the Additional Director of Agriculture (Horticulture), Botanical Garden, Puducherry.

- (f) The work of laying micro-irrigation system will be executed by the manufacturer/dealer under the supervision of Agricultural Officer (Engineering).
- (g) Check measurement work will be done in M Book by the Agricultural Officer (Engineering) concerned and check measured by the Deputy Director (Agricultural Engineering), Soil Conservation.
- M. Distribution of critical inputs.— In the case of distribution of other critical inputs like water soluble fertilisers, planting material, plant growth regulators and crop protectants, the Additional Director of Agriculture (Horticulture), Botanical Garden, Puducherry, will place indentP to PASIC/PKKVK indicating the quantum of inputs required for the Scheme. The Agricultural Officer shall issue permits to the approved farmers for distribution of inputs based on the Department recommendation to the approved beneficiary. After distribution of inputs PASIC/PKKVK will submit bills along with one copy of permit issued by the Agricultural Officer for settlement.
- N. Release of fund to the manufacturer/dealer.— On completion of the laying of drip/fertigation system, the implementing agency shall present the bill duly certified by the Deputy Director (Agricultural Engineering) and countersigned by the Additional Director of Agriculture (T&V)/Additional Director of Agriculture (Horticulture) as the case may be and settled by the Directorate of Accounts and Treasuries, Puducherry.

Bill for administration expenses/service charges @ 1% to the implementing agency shall be prepared and claimed separately.

- (ii) As and when the joint inspection is carried out, the Committee will recommend the eligible amount to be disbursed to the micro-irrigation supplier. The same will be released on ECS mode to the contractor/supplier/manufacturer/dealer after obtaining necessary approval of the competent authority. The subsidy amount eligible for the individual farmer would be as per the pattern of assistance of the RKVY Scheme, which would be limited to a maximum of ₹ 1.15 lakhs/hectare/beneficiary for micro-irrigation under Precision Farming for horticulture crops and ₹ 1.75 lakhs/hectare/beneficiary for micro-irrigation under Sustainable Sugarcane Initiative(SSI) including Goods and Services Tax for both categories.
- (iii) Before sending work order to the micro-irrigation suppliers, the micro-irrigation suppliers have to submit 5% Bank Guarantee of the value of the work to the Office of the Additional Director of Agriculture (Horticulture) as a guarantee for their after indicative service for a period up to 31-03-2020.
