ORDER

(UNDER SECTION 133 OF Cr.P.C.)

Whereas, the Good Health and Wellbeing has been adopted by United Nation (UN) as one of the important goals to be achieved among the 17 Sustainable Developmental Goals (SDG). As such, it is the bounden duty of the Administration to strive to achieve the same in letter and spirit. Disease like Malaria is identified as one of the major challenge to achieve the goal, particularly in the developing Countries;

Whereas, many cases of malaria and dengue are reported in Puducherry region in the recent period. The Health Department is carrying out field inspection to identify the source of spread of the disease to contain the same wherever required;

Whereas, on inspection of the areas it is observed that at several places, the drains have been blocked by accumulation of silt and dumping garbage and other materials. Also garbage and waste materials are found dumped at many places;

Whereas, the above situation would substantially cause to spread of various vector borne diseases including malaria and dengue in particular;

Whereas, the north east monsoon is fast approaching necessitating the District Administration to take preventive action to avoid overflowing of drain water onto roads and inundation of low lying areas;

Now, therefore, I, Dr. Arun. T. I.A.S., District Magistrate hereby direct the Departments concerned *viz.*, Public Works and Local Administration to take necessary immediate following actions:-

- (i) To desilt all types of drains and canals and channels under their respective jurisdiction in a time bound manner.
- (ii) To identify source reduction strategies like preventing stagnation of water on public places like roads and drains.
- (iii) To remove the garbages, waste materials wherever dumped.
- (iv) To remove all artificial materials where water stagnates and closing dysfunctional tube well and tanks.
