ORDER

(UNDER SECTION 144 OF Cr.P.C.)

Whereas, it is hereby informed to public in general that Chinna Veerampattinam Beach (Eden beach), Ariyankuppam Commune, Puducherry, has been nominated for Blue Flag Certification (an International accreditation for safe and clean beach);

And whereas, it is further informed that an area covering 3 sq.km. area from the designated beach area at Chinna Veerampattinam has been identified as "No Plastic Zone" (area south of Veerampattinam beach to Chunnambar Paradise beach). A "No Plastic Zone" is the place where tourists or visitors are strictly restricted to use plastics within the 3 sq.km. areas of the designated beach and vendors are completely restricted to sell plastics within this zone;

Now, therefore, in exercise of the powers conferred upon me by section 144 of Criminal Procedure Code, 1973, I, Dr. T. Arun, I.A.S., District Magistrate, Puducherry, do hereby make the following written order for strict compliance by the general public, including the citizens of Puducherry and visitors that:

- (i) "Public is hereby advised to restrict plastic use and selling of plastic items within the 3 sq.km. areas from the designated beach. No other activities which lead to increasing of plastic waste/plastic pollution can be undertaken in this designated area"
- (ii) This order shall come into force with immediate effect from 08-10-2019.
- (iii) A person contravening this order shall be punishable under section 188 of the India Penal Code, 1860.

As the notice cannot be served individually on all concerned, the order is hereby passed *ex parte*. This shall be published for the information of the public by affixing copies on the notice board and all the offices located within the Ariyankuppam Commune Panchayat, including every public place.
