#### IN THE COURT OF THE SUBDIVISIONAL MAGISTRATE (NORTH) AT PUDUCHERRY

ORDER

(UNDER SECTION 144 OF Cr. P.C./3468)

Whereas, it has been brought to the notice of the undersigned by the Station House Officer, Ariyankuppam Police Station, Puducherry that the fishermen groups of Nallavadu and Veerampattinam attacked each other at Paradise Beach thereby disturbing the public peace and tranquility;

And whereas, based on the above submission of the Station House Officer, Ariyankuppam Police Station, I am of the opinion that there are sufficient grounds for proceeding under section 144 of the Code of Criminal Procedure, 1973, to prohibit the action mentioned in pre - para which may pose threat to the community and detrimental to public peace and tranquility;

Now, therefore, based on the reasons stated above, I, T. Sudhakar, Subdivisional Magistrate (North), Puducherry, hereby invoke the provisions of section 144 of the Code of Criminal Procedure, 1973 and prohibit the assemblage of five or more persons in public streets or thoroughfares or in public places and prohibit the carrying of any type of weapons, sticks, banners, placards, *etc.*, by any person and also prohibit the shouting of slogans and using of loud speakers and acting in any other manner which may cause danger to human life and detrimental to public peace and tranquility in the areas of Nallavadu and Veerampattinam, Puducherry for a period of one month from the date of this Order or till any further orders passed by the Competent Authority revoking this prohibition as per law, whichever is earlier.

This Order does not apply to purely religious functions, marriages, funerals and inside the educational institutes and hospitals.
