**ORDER**

(UNDER SECTION 133 OF Cr. P.C.)

Whereas, the Supreme Court Committee on Road Safety has issued many directions and one among is “Set targets for mapping all the ambulances in the State, both public and private so that they can be accessed.....”;

Whereas, in compliance to the Hon’ble Supreme Court direction and also as discussed in the District Road Safety Committee on 23rd April 2019 and in order to ensure effective mapping of ambulance in the District, it is pertinent to focus on availability and accessibility of ambulance. Also the Supreme Court Committee on Road Safety has set target to reduce 10% in the rate of death reported due to accident per annum;

Whereas, it has been observed that many ambulances does not have minimum facility to cater to the sick/injured/disabled patients and merely used as a transport vehicle. This amounts to violation of the National Ambulance Code. Also it would be detrimental if, they are allowed to ply on the road because many deaths may be apparent during transport mainly for absence of facilities;

Now, therefore, I, Dr. Arun. T, I.A.S., District Magistrate hereby direct the Departments concerned viz., Health and Transport to take necessary immediate following actions to ensure the above services:

1. The Transport Department, Puducherry, to ensure fixing of GPS in all ambulances (Private, Government and Aided), so that all the ambulances are equally and adequately distributed throughout the District and the victim of accident if happens, can be moved to the nearest Hospital without delay.

2. The Health Department to ensure availability of health infrastructure viz., equipments, medicines, *etc.*, in all the ambulances (Private, Government and Aided), so that the persons would be having adequate care in the ambulance thereby reducing the mortality of the road accident.
