And whereas, the Station House Officer, Odiansalai Police Station, Puducherry, has filed a case against you *vide* IR.No. 134/2019 under section 144 of Cr.P.C., dated 04-10-2019. It is stated by the Station House Officer, Odiansalai Police Station that you have formed a gang of rowdies and bent upon indulging in crime such as murder, assault, intimidation, rioting, obstructions, annoyance, damages to public and private properties and disturbance to the public tranquility and order, and you have created panic in the minds of local inhabitants and, the farmers and business community in the rural limit. It is also stated that you have become a source of terror among the public. As a result, the people of the locality being afraid of you and do not come forward to lodge any complaint against you. It is also stated that even witnesses don't come forward voluntarily to give evidence against you in the cases where you are the accused;

And whereas, it is also stated in the IR that the Station House Officer has received reliable information that you are desperate and is in dire need of money to maintain your group of rowdy elements and to meet expenses in connection with the trial in the pending criminal cases against you.
