In supersession of the G.O. Ms. No. 19, dated 27-03-2012 of the Chief Secretariat (Health), Puducherry, the methodology for filling up of various Direct Recruitment

vacancies of Group-‘B’ (Non-Gazetted) and Group-‘C’ Technical posts in Health Department henceforth shall be as follows:

1. The Technical Posts which are to be filled up on Direct Recruitment basis as per the Recruitment Rules of the relevant posts shall be filled up only through Written Competitive Examination.

2. The posts carrying Educational/Technical qualification as per Recruitment Rules, which does not require any experience shall be filled up 100% through Open Competitive Examination.

3. The post carrying Educational/Technical qualification as per Recruitment Rules and requiring experience shall be filled up by giving 90% weightage marks for Open Competitive Examination and 10% weightage marks for practical examination.

Accordingly, approval of the Lieutenant-Governor is accorded for the adoption of the above methodology for filling up of the Group-‘B’ (Non-Gazetted) and Group-‘C’ posts by Direct Recruitment in Health Department, Government of Puducherry.

The Written Competitive Examination shall be conducted by the Examination Cell of Department of Personnel and Administrative Reforms.
