NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with the Notification No. F.5/4/65-GP, dated 11th January 1965 of the Ministry of Home Affairs, Government of India, New Delhi and in consultation with the High Court of Judicature at Madras *vide* Letter in R.O.C.No. 13636 and 27261/2019/Pondy, dated 12-02-2020 of the Deputy Registrar, High Court of Judicature at Madras, and all other powers enabling him in this behalf, the Lieutenant-Governor, Puducherry, is pleased to make the following rules further to amend the Puducherry Judicial Subordinate Service Rules, 1979 issued under G.O.Ms.No. 17/79-LLD., dated the 20th June, 1979 of the Law and Labour Department, Puducherry and published in the Extraordinary Gazette No. 90, dated 30th June, 1979, namely:—

1. *Short title and commencement.*—(1) These rules may be called the Puducherry Judicial Subordinate Service (Amendment) Rules, 2020.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. *Amendment of rule 13.*—In the Puducherry Judicial Subordinate Service Rules, 1979 (hereinafter referred to as the said rules), in Part-III, in rule 13, for the existing rule, the following shall be substituted, namely:-

“13. The Selection Committee shall consist of the following:

- “(1) Chief Judge, Puducherry — Chairman
- (2) Judicial Officer nominated by the High — Member Court, Madras
- (3) Judicial Officer nominated by the High — Member Court, Madras”.
