NOTIFICATION

The following notification is issued for the general information of public and strict compliance.

The Ministry of Environment, Forest and Climate Change, Government of India, has notified the rules, namely, "The Construction and Demolition Waste Management Rules, 2016" G.S.R. (E), dated 29-03-2016 and published it in the Gazette of India Part-II, Section-3, Sub-section (ii).

2. Rule 6 (1) of the said rules lays down that the Local Authority shall issue detailed directions with regard to proper management of construction and demolition waste within its jurisdiction in accordance with the provisions of the said rules. Further, rule 6(5) states that the Local Authority shall get the collected waste transported to appropriate sites for processing and disposal.

3. Therefore, the site No. 34, Re-survey No. 68 at Truck Terminal, Mettupalayam in Oulgaret Municipality, is available for the public to store/deposit construction and demolition waste (Boundaries: North: RS No. 68 pt., South: RS No. 66/67, East: RS No. 68 pt., West: Tamil Nadu) and Drain Silt Waste (Boundaries: North: RS No. 69, South: RS No. 68 pt., East: RS No. 68 pt., West: Tamil Nadu).

4. Therefore, any person or association of persons or institutions, residential and commercial establishments including Public Works Department, Indian Railways, Airport, Port and Harbour and Defence Establishments who undertake construction or demolition of any civil structure which generate construction and demolition waste shall deposit the construction and demolition waste only on the site mentioned at para 3 above.

5. The construction and demolition waste only shall be deposited on the site at para 3 above. No other waste shall be mixed with the construction and demolition waste.

6. No construction and demolition waste shall be deposited by any waste generator at any time on any public street, pavements, drains, public spaces or vacant sites, or any location other than the site mentioned at para 3 above.
