NOTIFICATION

Whereas, Dr. G.L. Upadhyaya, Senior Public Analyst, Department of Food and Drugs Testing, Puducherry, was notified as Food Analyst for the whole of the Union territory of Puducherry, *vide* G.O. Ms. No. 58, dated 21-10-2011 of Chief Secretariat (Health), Puducherry;

And whereas, Dr. G.L. Upadhyaya was admitted into retirement on attaining the age of superannuation with effect from 30-09-2019 *vide* G.O. Ms. No. 48, dated 28-08-2019 of Health Secretariat, Puducherry;

And whereas, Thiru R. Ilanthirayan, Bacteriologist, was ordered to look after the current duties of Senior Public Analyst, Department of Food and Drugs Testing, Puducherry, *vide* Order No. A.32013/H7/Health/2019, dated 24-10-2019 of Chief Secretariat (Health), Puducherry;

And whereas, the said Food Safety and Standards Act, 2006 provides for appointment of Food Analyst and the said Food Safety and Standards Rules, 2011 prescribes qualification for appointment of Food Analyst;

Now, therefore, in supersession of the G.O. Ms. No. 58, dated 21-10-2011 of the Chief Secretariat (Health), Puducherry, save as respects things done or omitted to be done before such supersession and in exercise of the powers conferred by section 45 of the Food Safety and Standards Act, 2006 (34 of 2006), read with rule 2.1.4 of the Food Safety and Standards Rules, 2011, the Commissioner of Food Safety-cum-Secretary to Government (Health), Puducherry, is pleased to appoint Thiru R. Ilanthirayan, Bacteriologist, who was ordered to look after the current duties of Senior Public Analyst, Department of Food and Drugs Testing, Puducherry as 'Food Analyst' for the whole of the Union territory of Puducherry for the purposes of performing functions under the said Act and Rules/Regulations made thereunder.
