(UNDER SECTION 144 OF Cr.P.C.)

Whereas, it has been submitted by the Station House Officer, Ariyankuppam Police Station, Puducherry, that you are involving in various offences against public tranquility, offences affecting property and offences affecting human body and that you have become a perennial source of threat to the community, public peace and order;

And whereas, I am convinced of your involvement in various criminal cases as under—

And whereas, it is evident from the above cases that you have involved in committing serious offences which would endanger the life of innocent public and their peace and order. Your vengeful acts along with your accomplices against your opponents have created panic in the minds of the people;

And whereas, the Station House Officer, Ariyankuppam Police Station, Puducherry, has filed a case against you through the Superintendent of Police (South) Puducherry *vide* IR.No. 76/2019 under section 144 of Cr.P.C., dated 01-04-2019. It is stated by the Station House Officer, Ariyankuppam Police Station, that you have formed a gang of rowdies and bent upon indulging in crime such as murder, hurt, criminal trespass, criminal intimidation, danger to the human life and properties and disturbance to the public tranquility and order, and you have created panic in the minds of local inhabitants and, farmer and business community in the rural limit. It is also stated that you have become a source of terror among the public.

As a result, the people of the locality being afraid of you and do not come forward to lodge any complaint against you. It is also stated that even witnesses don't come forward voluntarily to give evidence against you in the cases where you are the accused;

And whereas, it is also stated in the I.R that the Station House Officer has received reliable information that you are desperate and is in dire need of money to maintain your group of rowdy elements. It is also stated that you are hatching plans to threaten the business people in the Puducherry area and extort money from them by threatening, but, the public do not come forward to lodge any complaint against you due to fear. You also earned displeasure among a section of other rowdy group in the area on account of the grudge against you and hence, rival group is also waiting opportunity to take revenge upon you. Hence, the Station House Officer, Ariyankuppam Police Station, Puducherry, has prayed to invoke provisions under section 144 of Cr.P.C. against you not to enter into the jurisdiction of this Court for a period of two months as to prevent danger to the human life and properties, and disturbance to the public tranquility and order;

And whereas, summon was served for your appearance on 06-02-2020 to file your explanation/objection as to why the Subdivisional Magistrate (North), Puducherry, should not order to prevent you from entering into the North region under section 144 of Cr.P.C. You have put forth your side which is not convincing;

And whereas, based on the report laid before me, I am of the opinion that if, you are allowed to reside within the limits of my jurisdiction, you will continue to indulge in and also motivate serious offences like murder, hurt, criminal trespass, criminal intimidation, obstructions, annoyance, *etc.*, and danger to the human life and properties thereby become a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C. is invoked to take action against you to prevent harm to life and properties of citizens and uphold public peace and order;

And whereas, I am satisfied that you are an habitual offender that your activities will endanger human life and properties and your presence is a threat to public tranquility in my Subdivision. Therefore, an immediate action is required for curtailing your illegal activities in the locality;

Now, therefore, based on the reasons stated above, I, T. Sudhakar, Subdivisional Magistrate (North), Puducherry, in exercise of powers conferred under Code of Criminal Procedure, 1973, do hereby prohibit you under section 144 of Cr. P.C. from entering into the region under the jurisdiction of the Subdivisional Magistrate Court (North), for a period of one month from the date of this order, or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry. However, you may appear either in person or by Pleader before the undersigned to represent against this order.
