NOTIFICATION

The Lieutenant-Governor, Puducherry, hereby makes the following bye-laws further to amend the rules relating to the composition of the Management Committee for the Armed Forces Flag Day Funds and the enhancement of the financial assistance to Ex-servicemen and their families registered in the Department of Sainik Welfare, Government of Puducherry issued *vide* Notification in G.O. Ms. No. 49, dated 28th September, 2012 of the Home Department, Government of Puducherry and published in Part-II, No. 37, dated 3rd October, 2012 of the Extraordinary Gazette of Puducherry, namely:—

1. Short title and commencement.—(i) These bye-laws may be called "The Management Committee for Armed Forces Flag Day Funds (Amendment) Bye-laws, 2020".

(ii) They shall come into force with immediate effect.

2. Amendment of clause 3.—In the Management Committee for Armed Forces Flag Day Funds Bye-laws (hereinafter referred to as the said bye-laws), for the existing clause (3), the following shall be substituted, namely:—

"3. Composition of Management Committee For Armed Forces Flag Day Funds.—The Management Committee of Armed Forces Flag Day Funds is an Apex Body of the Department of Sainik Welfare, which formulates policies for resettlement, rehabilitation and welfare of Ex-servicemen and their families. The Management Committee shall have the following composition :—

5. Amendment of Clause 28.—In the said Bye-laws, in clause 28, for the existing clause, the following shall be substituted, namely:-

"28. Ex-servicemen who have completed the age of 60 years and above on the date of the issue of Festival grant to Ex-servicemen/widows preceding 31st March and all widows of Ex-servicemen irrespective of their age shall be issued with Festival Grant between the month of November and January of every year for the purchase of clothing and other provisions. The amount as decided by the Management Committee is to be credited in the beneficiary's Bank Account through RTGS/ NEFT."
