#### NOTIFICATION

The Market Committee of Karaikal was exempted from the provisions of sections 9 (1 to 4) and 11 of the Pondicherry Agricultural Produce Markets Act, 1973 (Act No. 3 of 1974), by virtue of section 37 by the said Act and the Members of the said Committee were nominated by the Lieutenant-Governor for the period from 12th September, 2017 to 12th March, 2018 vide G.O. Ms. No. 16/Ag., dated 12-09-2017;

The term of the office of the Members of the said Committee had expired on 12th March 2018;

The Government have considered it desirable that the Market Committee shall consist solely of Members appointed by it by nomination and have decided to exempt the Market Committee (Karaikal) from the provisions of the sections 9 and 11 of the said Act, for the period of one year from the date of issue of Notification as the Pondicherry Agricultural Produce Markets Act is proposed to be amended which will take considerable time.

In exercise of the powers conferred by section 37 of the Pondicherry Agricultural Produce Markets Act, 1973 (No. 3 of 1974), the Lieutenant-Governor, Puducherry, hereby exempts the Karaikal Market Committee from the provisions of section 9 and 11 of the said Act for the period of one year from the date of issue of Notification and subject to the following condition:
