NOTIFICATION

The Lieutenant-Governor, Puducherry, is pleased to make the following rules further to amend the Puducherry Freedom Fighters' Pension Rules, 1970 issued *vide* G.O. Ms. No. 51 Home (I), dated 20th July, 1970 of the Chief Secretariat (Home-I) Department, Government of Puducherry and published in the Extraordinary Gazette of Puducherry, No. 69, dated 30th July 1970, namely:-

1. *Short title and commencement.*— (i) These rules may be called the Puducherry Freedom Fighters' Pension (Amendment) Rules, 2020.

(ii) They shall be deemed to have come into force with effect from the 01st day of April 2020.

2. *Amendment of rule 5.*— In the Puducherry Freedom Fighters' Pension Rules, 1970 (hereinafter referred to as the said rules) in rule 5, (i) for the letters and figures "Rs. 8,000", the symbol and figures "₹ 9,000", shall be substituted.

(ii) in the said rule, for the words "in case of others," the following shall be substituted, namely, "in the case of State Freedom Fighters".

3. *Amendment of rule 6.*— In the said rules, in rule 6, (i) for the letters and figures "Rs. 8,000", the symbol and figures "₹ 9,000", shall be substituted.

(ii) in the said rules, for the words, "in the case of others," the following shall be substituted, namely, "in the case of State Freedom Fighters".
