## ORDER

Whereas, the lease period in respect of retail vends of Arrack and Toddy in the Union territory of Puducherry for the lease year 2019-2020 is up to the 30th day of June 2020;

2. And whereas, in normal circumstances, auction for the retail vends of Arrack and Toddy for the next lease year 2020-2021 should have been conducted in the month of June 2020 itself;

3. And whereas, due to the outbreak of Covid-19 pandemic and subsequent lockdown in the Union territory of Puducherry since March 2020, the auction process of retail vends of Arrack and Toddy could not be taken up as per the normal schedule;

4. And whereas, the Government in the circumstances have felt it expedient to extend the present lease period in respect of retail vends of Arrack and Toddy by 31 days;

5. Now, therefore, the Government is in pursuance of rule 143 of the Pondicherry Excise Rules, 1970, hereby extends the lease period of retail vends of Arrack and Toddy in the regions of Puducherry and Karaikal of the Union territory of Puducherry for a period of 31 days from 1st July 2020 to 31st July 2020 (both days inclusive) with same monthly kist amount and terms and conditions as notified in the Revenue Department's Notification No. 2201/DCE/TP/AUC/2019-20, dated 25-6-2019 published in the Part-I of the Extraordinary Gazette of Puducherry No. 117, dated 25-6-2019.
