(UNDER SECTION 144 OF Cr.P.C.)

Whereas, it has been submitted by the Station House Officer, Mettupalayam Police Station, Puducherry, that you are involving in various offences against public tranquility, offences affecting property and offences affecting human body and that you have become a perennial source of threat to the community, public peace and order;

And whereas, I am convinced of your involvement in various criminal cases as under—

Cr.No. 84/17 under sections 147, 148, 342, 302, 307 IPC, 149 IPC and 3 & 4 of Explosive Substances Act 1908, dated 19-10-2017 of Mettupalayam Police Station, Puducherry – Pending Trial.

And whereas, it is evident from the above cases that you have involved in committing serious offences which would endanger the life of innocent public and their peace and order. Your vengeful acts along with your accomplices against your opponents have created panic in the minds of the people;

And whereas, the Station House Officer, Mettupalayam Police Station, Puducherry, has filed a case against you through the Superintendent of Police (North), Puducherry *vide* IR.No. 74/2019 under section 144 of Cr.P.C., dated 29-12-2019. It is stated by the Station House Officer, Mettupalayam Police Station, that you have formed a gang of rowdies and bent upon indulging in crime such as murder, hurt, extortion, obstructions, annoyance, damages to public and private properties and disturbance to the public tranquility and order, and you have created panic in the minds of local inhabitants and, the farmer and business community in the rural limit. It is also stated that you have become a source of terror among the public. As a result, the people of the locality being afraid of you and do not come forward to lodge any complaint against you. It is also stated that even witnesses don't come forward voluntarily to give evidence against you in the cases where you are the accused;

And whereas, it is also stated in the I.R. that the Station House Officer has received reliable information that you are desperate and is in dire need of money to maintain your group of rowdy elements. It is also stated that you are hatching plans to threaten the business people in the Puducherry area and extort money from them by threatening, but, the public do not come forward to lodge any complaint against you due to fear. It is further stated that you are involving in various offences by using aruval, knife to attack the victims. You also violated the conditions imposed by the Criminal Courts and have scant respect to the Judiciary and rule of law, and also earned displeasure among a section of other rowdy group in the area on account of the grudge against you and hence, rival group is also waiting opportunity to take revenge upon you;

And whereas, the Station House Officer, Mettupalayam Police Station, further submitted that if, you are allowed to reside in Mettupalayam limits, it is apprehended that you would continue to indulge in serious offences like assault, obstructions, annoyance, *etc.*, and thereby emerged as a perennial source of threat to the community and disturb public peace and order. Hence, the Station House Officer, Mettupalayam Police Station, has prayed to invoke provisions under section 144 of Cr.P.C. against you not to enter into the jurisdiction of this Court for a period of two months as to prevent danger to the human life and properties and disturbance to the public tranquility and order;

And whereas, summon was served for your appearance on 20-02-2020 and for subsequent hearing on 27-02-2020, 28-02-2020 to file your explanation/objection as to why the Subdivisional Magistrate (North), Puducherry, should not order to prevent you from entering into the North region under section 144 of Cr.P.C. You have failed to appear before the Court on hearing date and thereby violated the conditions imposed by the Court;

And whereas, based on the report laid before me, I am of the opinion that if, you are allowed to reside within the limits of my jurisdiction, you will continue to indulge in and also motivate serious offences like murder, hurt, damages to public and private properties, obstructions, annoyance, *etc.*, and thereby become a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C. is invoked to take action against you to prevent harm to life and properties of citizens and uphold public peace and order;

And whereas, I am satisfied that you are an habitual offender that your activities will endanger human life and properties and your presence is a threat to public tranquility in my Subdivision. Therefore, an immediate action is required for curtailing your illegal activities in the locality;

Now, therefore, based on the reasons stated above, I, T. Sudhakar, Subdivisional Magistrate (North), Puducherry, in exercise of powers conferred under Code of Criminal Procedure, 1973, do hereby prohibit you under section 144 of Cr. P.C. from entering into the region under the jurisdiction of the Subdivisional Magistrate Court (North), for a period of two months from the date of this order, or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry. However, you may appear either in person or by Pleader before the undersigned to represent against this order.

1. Cr.No. 57/2015 under sections 147, 148, 341, 427, 324, 307, 506(ii) r/w. 149 IPC, dated 02-09-2015 of Kalapet Police Station, Puducherry – Under Investigation.
2. Cr.No. 58/2016 under sections 294(b), 324, 506(ii) IPC r/w 34 IPC @ 143, 147, 148, 294(b), 307, 506(ii) IPC r/w 149 IPC, dated 08-06-2016 of Kalapet Police Station, Puducherry – Acquitted.
3. Cr.No. 115/2017 under sections 326, 506(ii) r/w 34 IPC, dated 24-11-2017 of Kalapet Police Station, Puducherry – Pending Trial.
4. Cr.No. 306/2019 under sections 147, 148, 294(b), 341, 324, 120(b), 307, 302 IPC, dated 11-07-2019 of Kottakuppam Police Station, Tamil Nadu – Under Investigation.

And whereas, it is evident from the above cases that you have involved in committing serious offences which would endanger the life of innocent public and their peace and order. Your vengeful acts along with your accomplices against your opponents have created panic in the minds of the people;

And whereas, the Station House Officer, Kalapet Police Station, Puducherry, has filed a case against you through the Superintendent of Police (East), Puducherry *vide* IR.No. 02/2020 under section 144 of Cr.P.C., dated 16-01-2020. It is stated by the Station House Officer, Kalapet Police Station, that you have formed a gang of rowdies and bent upon indulging in crime such as murder, hurt, extortion, obstructions, annoyance, damages to public and private properties and disturbance to the public tranquility and order, and you have created panic in the minds of local inhabitants and, the farmer and business community in the rural limit. It is also stated that you have become a source of terror among the public. As a result, the people of the locality being afraid of you and do not come forward to lodge any complaint against you. It is also stated that even witnesses don't come forward voluntarily to give evidence against you in the cases where you are the accused;

And whereas, it is also stated in the I.R. that the Station House Officer has received reliable information that you are desperate and is in dire need of money to maintain your group of rowdy elements. It is also stated that you are hatching plans to threaten the business people in the Puducherry area and extort money from them by threatening, but, the public do not come forward to lodge any complaint against you due to fear. It is further stated that you are involving in various offences by using deadly weapons to attack the victims. You also violated the conditions imposed by the Criminal Courts and have scant respect to the Judiciary and rule of law and also earned displeasure among a section of other rowdy group in the area on account of the grudge against you and hence, rival group is also waiting opportunity to take revenge upon you;

And whereas, the Station House Officer, Kalapet Police Station, further submitted that if, you are allowed to reside in Kalapet limits, it is apprehended that you would continue to indulge in serious offences like assault, obstructions, annoyance, *etc.*, and thereby emerged as a perennial source of threat to the community and disturb public peace and order. Hence, the Station House Officer, Kalapet Police Station, has prayed to invoke provisions under section 144 of Cr.P.C. against you not to enter into the jurisdiction of this Court for a period of two months as to prevent danger to the human life and properties and disturbance to the public tranquility and order;

And whereas, summon was served for your appearance on 20-02-2020 and for subsequent hearing on 27-02-2020, 28-02-2020 to file your explanation/objection as to why the Subdivisional Magistrate (North), Puducherry, should not order to prevent you from entering into the North region under section 144 of Cr.P.C. You have failed to appear before the Court on hearing date and thereby violated the conditions imposed by the Court;

2. Cr.No. 170/2010 under sections 147, 148, 302, 109 IPC & 3 of Explosive Substances Act, 1903 of Grand Bazaar Police Station, Puducherry – Pending Trial.
3. Cr.,No. 08/2011 under sections 150, 399, 402 IPC & 27 Arms Act, 1959 r/w 149 IPC of Lawspet Police Station, Puducherry – Pending Trial.

It is also stated that you have become a source of terror among the public. As a result, the people of the locality being afraid of you and do not come forward to lodge any complaint against you. Hence, the Station House Officer, Lawspet Police Station, has prayed to invoke provisions under section 144 of Cr.P.C. against you not to enter into the jurisdiction of this Court for a period of six months as to prevent danger to the human life and properties and disturbance to the public tranquility and order;

And whereas, summon was served for your appearance on 20-02-2020 and for subsequent hearing on 27-02-2020, 28-02-2020 to file your explanation/objection as to why the Subdivisional Magistrate (North), Puducherry, should not order to prevent you from entering into the North region under section 144 of Cr.P.C. You have put forth your side which is not convincing;

And whereas, based on the report laid before me, I am of the opinion that if, you are allowed to reside within the limits of my jurisdiction, you will continue to indulge in and also motivate serious offences like murder, extortion, damages to public and private properties, assault, obstructions, annoyance, criminal-intimidation, hurt, explodes country made bombs, *etc.*, and thereby become a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C. is invoked to take action against you to prevent harm to life and properties of citizens and uphold public peace and order;
