## **ORDER**

Whereas, the Management of M/s. Anglo French Textiles, Puducherry, had applied for prior permission under sub-section (1) of section 25-O of the Industrial Disputes Act, 1947 to close down the undertaking with effect from 30-04-2020 *vide* closure notice in Form QA, dated 21-01-2020 (resubmitted on 06-02-2020);

Whereas, as per sub-section (2) of section 25-O of the Act, the 'appropriate Government' after making an enquiry and after giving a reasonable opportunity of being heard to the employer, the workmen and the persons interested in such closure may, having regard to the genuineness and adequacy of the reasons stated by the employer, the interests of the general public and all other relevant factors, by order and for reasons to be recorded in writing, grant or refuse to grant such permission and a copy of such order shall be communicated to the employer and the workmen;

Whereas, the appropriate Government for granting or refusing to grant permission of closure under section 25-O of the Act is the 'Administrator';

Whereas, in exercise of the powers conferred by section 25-O of the Industrial Disputes Act, 1947 (Central Act 14 of 1947), the appropriate Government *i.e.*, the Administrator hereby appoints Shri. D. Ramabathiran, District Judge (Retired), Ex-Puducherry Judicial Service Officer to conduct an enquiry in accordance with the provisions envisaged under section 25-O of the Act;

Whereas, it is directed that the Labour Department will provide the required Secretarial assistance and office space to the Authority;

Whereas, Shri. D. Ramabathiran, District Judge (Retired) will be paid a lump sum remuneration of ₹ 2.00 lakhs;

Now, therefore, Shri. D. Ramabathiran, District Judge (Retired), shall conduct the enquiry as laid down in sub-section (2) of section 25-O of the Act and furnish the report within one week from the date of issue of the order.
