NOTIFICATION

The Ministry of Environment, Forest and Climate Change, Government of India, has notified this rules, namely, "The Construction and Demolition of Waste Management Rules, 2016" G.S.R. 317 (E), dated 29-03-2016 and published in the Gazette of India, Part-II, section-3, sub-section (ii).

2. Rule 6 (1) of the rules lays down that the Local Authority shall issue detailed directions with regard to proper management of construction and demolition waste within its jurisdiction in accordance

with the provisions of the said rules. Further, rule 6 (5) states that the Local Authority shall get the collected waste transported to appropriate sites for processing and disposal.

3. The following site is therefore earmarked for setting up of the storage, processing and recycling facilities for construction and demolition waste and silt:

- 4. Therefore, any person or association of persons of institutions, residential and commercial establishments including Public Works Department, Indian Railways, Airport, Port and Harbour and who undertake construction of or demolition of any civil structure which generate construction and demolition waste shall deposit the construction and demolition waste only on the site mentioned at para 3 above.
- 5. The construction and demolition waste only shall be deposited on the site at para 3 above. No other waste shall be mixed with the construction and demolition waste.
