THE APPROPRIATION ACT, 2020

(Act No. 2 of 2020)

(30-03-2020)

AN

ACT

to authorise payment and appropriation of certain further sums from and out of the Consolidated Fund of the Union territory of Puducherry for the services in respect of the period from 1-4-2019 to 31-3-2020.

BE it enacted by the Legislative Assembly of Puducherry in the Seventy-first Year of the Republic of India as follows :—

Short title.

1. This Act may be called the Appropriation Act, 2020.

Supplementary appropriation of ₹ 463,26,03,000 from and out of the Consolidated Fund of the Union territory of Puducherry for the period from 1-4-2019 to 31-3-2020.

2. From and out of the Consolidated Fund of the Union territory of Puducherry, there may be paid and applied further sums not exceeding those specified in column (5) of the Schedule, amounting in the aggregate to the sum of Four hundred sixty-three crores, twenty-six lakhs and three thousand rupees, towards defraying the several charges which will come in the course of payment during the period from 1-4-2019 to 31-3-2020 in respect of the services specified in column (2) of the Schedule.

Appropriation.

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the Union territory of Puducherry by this Act, shall be appropriated for the services and purposes expressed in the Schedule in relation to the said period.

THE APPROPRIATION (VOTE ON ACCOUNT) ACT, 2020
(Act No. 3 of 2020)

(30-03-2020)

AN

ACT

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the Union territory of Puducherry for the services in respect of the months of April, May and June 2020.

BE it enacted by the Legislative Assembly of Puducherry in the Seventy-first Year of the Republic of India as follows :—

1. This Act may be called the Appropriation (Vote on Account) Act, 2020. Short title.

2. From and out of the Consolidated Fund of the Union territory of Puducherry, there may be paid and applied sums not exceeding those specified in column (5) of the Schedule, amounting in the aggregate to the sum of Two thousand four hundred and forty-six crore rupees, towards "Vote on Account" for defraying the several charges which will come in course of payment during the months of April, May and June 2020 in respect of the services specified in column (2) of the Schedule. Vote on Account for ₹ 2446,00,00,000 out of the Consolidated Fund of the Union territory of Puducherry for the months of April, May and June 2020.

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the Union territory of Puducherry by this Act, shall be appropriated for the services and purposes expressed in the Schedule in relation to the said period. Appropriation.
