NOTIFICATION

The Ministry of Law and Justice (Legislative Department), Government of India, has enacted the new Act viz., 'The Rights of Persons with Disabilities Act, 2016' (No 49 of 2016), dated 27-12-2016 and was notified in the Gazette of India vide section 1, Part-II of the Extraordinary No. 59, dated 28-12-2016 and the Ministry of Home Affairs has delegated the powers of the State Government under the Act to the Administrator of all the Union Territories vide Notification S.O 3870(E), dated 12-12-2017 and was published vide Part-II, Section 3, Sub-section (ii) of Extraordinary No. 3394 of the Gazette of India, dated 12-12-2017.

The Puducherry Rights of Persons with Disabilities Rules, 2018 for the Union territory of Puducherry under section 101 of the Act has been notified *vide* G.O. Ms. No. 12/SWS/2018-19, dated 19-12-2018 and published *vide* Part-II of Extraordinary Gazette, Government of Puducherry *vide* Gazette No.77, dated 21-12-2018. Further, in accordance with section 66 of the abovesaid Central Act, every State Government shall, by notification, constitute a Body to be known as the State Advisory Board on Disability.

2. Accordingly, the Lieutenant-Governor, Puducherry, is pleased to constitute the State Advisory Board of the Union territory of Puducherry as appended to this notification in the Appendix.

3. The non-official Members of the State Advisory Board on Disability shall be paid daily allowance of rupees five hundred per day for each day of the actual meetings of the said Board. The non-official Members residing outside the Puducherry region shall be paid daily allowance and travelling allowance for each day of the actual meetings of the said Board at the rates admissible to a Group-B or equivalent Officer of the State Government.

4. The terms and conditions of service of Members and their disqualification shall be as defined under sections 67 and 68 of the Rights of Persons with disabilities Act, 2016.

5. As per the section 70 of the Rights of Persons with Disabilities Act, 2016, the State Advisory Board on Disability shall meet at least once in every six months and shall observe such rules or procedure in regard to the transaction of business at its meetings as specified under rules 11 to 18 of the Puducherry Rights of Persons with Disabilities Rules, 2018.

6. The State Advisory Board on Disability shall also discharge functions as prescribed under section 71 of the Rights of Persons with Disabilities Act, 2016.
