NOTIFICATION

In exercise of the powers conferred by rule 11(2)(n) of the Rules and Regulations of the Engineering College (Pondicherry) Society [Pondicherry Engineering College, Puducherry], the Governing Body of the Engineering College (Pondicherry) Society [Pondicherry Engineering College, Puducherry] hereby makes the following rules regulating the method of recruitment of Group 'A' post of "Principal" in the Engineering College (Pondicherry) Society [Pondicherry] under the Directorate of Higher and Technical Education, Government of Puducherry, namely:—

1. Short title and commencement.— (i) These rules may be called the Group 'A' post of "Principal" in the Engineering College (Pondicherry) Society [Pondicherry Engineering College, Puducherry] Recruitment Rules, 2019.

(ii) These rules shall come into force on and from the date of its publication in the Official Gazette.

2. Number of post, its classification and Level in the Pay Matrix.— The number of the said post, its classification and Level in the Pay Matrix attached thereto, shall be as specified in columns (2) to (4) of the said Schedule annexed hereto.

3. Method of recruitment, age-limit and other qualifications.— The method of recruitment to the said post, age-limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the said Schedule.

4. Disqualifications.- No person,-

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Governing Body of the Engineering College (Pondicherry) Society [Pondicherry Engineering College, Puducherry], may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage, and there are other grounds for so doing, exempt any person from the operation of this rule.

5. *Power to relax.*— Where the Governing Body in the Engineering College (Pondicherry) Society [Pondicherry Engineering College, Puducherry], is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving.— (1) Nothing in these rules shall affect the reservations, relaxations in upper age-limit and other concessions required to be provided for the Scheduled Castes, the Schedules Tribes and other special categories of persons in accordance with the orders issued by the Government from time to time in this regard.
