NOTIFICATION

In partial modification of the G.O. Ms. No. 37/Ag., dated 18-03-2020 of Chief Secretariat (Agriculture), Puducherry, published in the Extraordinary Gazette Part-II, No. 16, dated 07-04-2020, the Hon'ble Lieutenant-Governor, Puducherry, is pleased to approve the proposal of the Department of Agriculture and Farmers Welfare under the "Nammazhvar Agriculture Rejuvenation Mission" for extension and

enhancement of financial assistance of the components “Extending subsidy on cultivation expenses/production incentive to farmers cultivating field crops *in lieu of* input and back-ended investment subsidy under Crop Production Technology (CPT) Scheme” and for providing additional financial assistance for the Scheduled Caste farmers and for the said purpose, hereby makes further Addendum to the G.O at Para 4 (i) and (iv) and Clause II (i) and (iv) and Clause III (v) and (vi) of the Guidelines as follows:-
