Whereas, it has been made to appear to me that you have trivial and scant respect to the judiciary and rule of law and are involved in various offences against public tranquility, offences affecting property and human body and that you have become a perennial source of threat to the community, public peace and order;

And whereas, I am convinced of your involvement in various criminal cases under (1) Cr.No. 88/2018 under section 302 IPC r/w 34 IPC, dated 05-11-2018 of Thirukkanur Police Station, Puducherry, (2) Cr.No. 160/2019 under section 286, 338 IPC r/w 34 IPC and 3&4 of Explosive Substances Act, 1908, dated 09-07-2019 of Villianur Police Station, Puducherry and transferred to Sedarapet Police Station, Puducherry, (3) Cr.No. 85/2019 under section 27 of the Arms Act, 1959 @ 27 of the Arms Act, 1959 and section 120-B r/w 34 IPC @ 27 of the Arms Act, 1959, section 4 of Explosive Substances Act, 1908 and section 120-B r/w 34 IPC of Thirukkanur Police Station, Puducherry, dated 30-11-2019. The Case is Under Investigation, (4) Cr.No. 26/2020 under section 5 of Explosive Substances Act, 1908 r/w 34 IPC of Mudaliarpur Police Station, Puducherry, dated 10-02-2020. The case is Under Investigation, (5) Cr.No. 26/2020 under section 380 IPC of Sedarapet Police Station, Puducherry, dated 16-05-2020, the case is Under Investigation and your vengeful acts along with your accomplices against your opponents have created panic in the minds of the people;

And whereas, the Station House Officer of Sedarapet Police Station has filed a case against you *vide* IR.No. 26/2020 under section 144 of Cr.P.C., dated 14-08-2020. It is stated by the Station House Officer, Sedarapet Police Station that you are indulging in crime such as murder, extortion, preparing country made bombs and disturbance to the public tranquility and order, and you have created panic in the minds of local inhabitants. It is also stated that you have become a source of terror among the public. As a result, the people of the locality being afraid of you and do not come forward to lodge any complaint against you. It is also stated that even witnesses don't come forward voluntarily to give evidence against you in the cases where you are the accused;

And whereas, the Station House Officer, Sedarapet Police Station, further, submitted that if, you are allowed to reside in the Subdivisional Magistrate (South) Jurisdiction limits, it is apprehended that you would continue to indulge in serious offences like murder, extortion, damages to public and private property and disturbance to the public tranquility and order, *etc.*, and thereby emerged as a perennial source of threat to the community and disturb public peace and order;

And whereas, summons were served for your appearance on 17-09-2020 to file your explanation/objection as to why the Subdivisional Magistrate (South), Villianur, should not order to prevent you from entering into the south region under section 144 (3) of Cr.P.C. You have put forth your side which is not convincing;

And whereas, based on the report laid before me, I am of the opinion that if, you are allowed to reside within the limits of this jurisdiction, you will continue to indulge in and also motivate serious offences and thereby become a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C. is invoked to take action against you to prevent harm to life and properties of citizens and uphold public peace and order;

And whereas, I am satisfied that you are an habitual offender, that your activities will endanger human life and properties and your presence is a threat to public tranquility in this Subdivision. Therefore, an immediate action is required for curtailing your illegal activities in the locality;

Now, therefore, based on the reasons stated above, I, A. Asvin Chandru, I.A.S., Subdivisional Magistrate (South), Villianur, Puducherry, in exercise of powers conferred under Code of Criminal Procedure do hereby prohibit you under section 144 of Cr.P.C. from entering into the region under the Jurisdiction of Subdivisional Magistrate Court (South), for a period of two months from the date of this order, or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry. However, you may appear either in person or by pleader before the undersigned to represent against the order.
