- (i) That two (02) numbers of Idols were found at the work site belonging to Sri Prathaba Simmeswarar and Sri Lakshmi Narayanaperumal Devasthanam at Thiruvasal Thidal, Sethur, Thirunallar Commune, Karaikal District, during excavation work for a Government Project "Integrated Farming System" under PMKSY Scheme by the Block Development Office, Karaikal.
- (ii) That two (02) numbers of Idols namely, Lord Perumal (metal) and Lord Kalinganarthanar Krishnar Idol (metal) were seized from the work site at around 3.30 p.m. on 23-09-2020 by the Tahsildar, Taluk Office, Thirunallar.
- (iii) That the two Idols were weighed by the Assistant Controller of Legal Metrology (ACLM), Karaikal, in the presence of the Deputy Collector (Revenue), Karaikal.
- (iv) Lord Perumal Idol was found weighing 12.020 kgs. and Lord Kalinganarthanar Krishnar Idol was found weighing 42.060 kgs.
- (v) And that the two Idols were deposited with the Treasury, Karaikal, in duly packed and sealed trunk boxes by the Deputy Collector (Revenue), Karaikal, on the same day.
- 2. Now, any/all person(s) claiming the treasure, or any part thereof, shall appear personally or by agent before the undersinged on 03-02-2021 (Wednesday) at 4.30 p.m. at the Collectorate, Karaikal, with relevant documents to prove his/her claim over the treasure.
- 3. Any person having any right to the treasure or any part thereof, as owner of the place in which it was found or otherwise and not appearing as required by this notification issued under section 5 of Indian Treasure-Trove Act, 1878, shall forfeit such right.
