3. The facts which led up to the petition are briefly as follows: The case is submitted by the Station House Officer, Muthialpet Police Station, Puducherry, through the Superintendent of Police (East), Puducherry *vide* I.R.No. 20/2020 under section 144 of Cr.P.C., dated 09-11-2020. Therein, it has been stated that the Counter Petitioner has formed a gang of rowdies and bent up on indulging in crime such as criminal intimidation, hurt, extortion, disturbance to the public tranquility and order. The Counter Petitioner has created panic in the minds of local inhabitants and the business people in the Muthialpet Police Station, Puducherry, limits. It is also stated that he is leading lavish life with the money earned from the public and business people by threatening. As a result the people of the locality being afraid of the Counter Petitioner do not come forward to lodge any complaint against him. It is also stated that even witnesses don't come forward voluntarily to give evidence against him in the cases where he is the accused. In this connection, the Petitioner had stated that the following criminal cases were registered against the Counter Petitioner.

It is further stated that he is very active notorious rowdy element and therefore, his criminal activities cannot be prevented by invoking the mere security proceedings under the Cr.P.C.

5. The Petitioner further submitted that if, Counter Petitioner is allowed to reside in Puducherry limits, it is apprehended that he would continue to indulge in serious offences like murder, attempt to murder, Explosive Substances Act, hurt, damages, assault and thereby emerged as a perennial source of threat to the community and disturb public peace and order. Hence, the Station House Officer, Muthialpet Police Station, Puducherry, has prayed to invoke provisions under section144 of Cr.P.C. against the Counter Petitioner do not to enter into the jurisdiction of this Court for a period of two months as do prevent danger to the human life and properties and disturbance to the public tranquility and order;

6. The proceeding was started by affording an opportunity to the Counter Petitioner to show cause against the petition filed by the Petitioner. A notice was served to both the parties on 10-02-2021 to appear for the hearing on 18-02-2021 at 11.00 a.m. It was instructed to serve the notice to the Counter Petitioner through the Station House Officer, Muthialpet Police Station, Puducherry. During the course of enquiry on 18-02-2021, both the Petitioner and Counter Petitioner were called absent. Hence, petition dismissed for default due to absence of Petitioner.

7. On 01-03-2021, the Station House Officer, Muthialpet Police Station, Puducherry, filed a restoration petition. A notice was served to both the parties on 01-03-2021 to appear for the hearing on 03-03-2021 at 11.00 a.m. It was instructed to serve the notice to the Counter Petitioner through the Station House Officer, Muthialpet Police Station, Puducherry. The notice for the Counter Petitioner was received by his wife, Tmt. G. Manju. The Service was held sufficient for the Counter Petitioner.

8. On 03-03-2021, the Petitioner G. Kalaiarasan, Sub-Inspector, Muthialpet Police Station, Puducherry and the Counter Petitioner were present. The learned Counsel Thiru B. Narasimmabalan, was present and represented on behalf of the Counter Petitioner.

9. I have heard both the sides and carefully gone through all the available records in file placed by the Petitioner. In the Police Information Report/Petition, it is stated that the activities of Thiru Gnanavel is in such a manner that they may cause breach of peace and create a problem of law and order and public tranquility. He has involved in crimes such as murder, assault, unlawful activities and disturbance to the public peace and order. There are 13 criminal cases registered against him in various Police Stations from 2010 onwards, among which 9 cases are pending trial before the Hon'ble Courts. I have also heard the oral submission of the Counsel for the Counter Petitioner. The learned Counsel for Counter Petitioner has stated that the Petitioner has filed this false case with an ulterior motive.

10. Up on hearing both sides and on perusal of the records submitted by the Petitioner, I am of the opinion that if, the Counter Petitioner is allowed to reside within the limits of my jurisdiction, Counter Petitioner will continue to indulge in and also motivate serious offences like murder, assault, damages to properties, *etc.*, and thereby become a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C. is invoked to take action against the Counter Petitioner to prevent harm to life and properties of citizens and uphold public peace and order:

Hence, I, M. Kandasamy, do hereby, in the capacity of Subdivisional Magistrate (North), Puducherry, in exercise of powers conferred under the section 144(1) of the Code of Criminal Procedure, pass this order and prohibit the Counter Petitioner Thiru Gnanavel, s/o. Munusamy, a resident of No. 53, Maravady Street, Kurusukuppam, Muthialpet, Puducherry, from entering into the region under the jurisdiction of the Subdivisional Magistrate Court (North), for a period of two months from the date of this Order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry. However, you may represent against this order before the undersigned by post or by Counsel.

Therein, it has been stated that the Counter Petitioner has formed a gang of rowdies and bent upon indulging in crime such as murder, intimidation, hurt, extortion, rioting, Arms Act, annoyance and disturbance to the public tranquility and order. The Counter Petitioner has created panic in the minds of local inhabitants and the business people in the Muthialpet Police Station, Puducherry, limits. It is also stated that he is leading lavish life with the money earned from the public and business people by threatening. As a result the people of the locality being afraid of the Counter Petitioner do not come forward to lodge any complaint against him. It is also stated that even witnesses don't come forward voluntarily to give evidence against him in the cases where he is the accused. In this connection, the Petitioner had stated that the following criminal cases were registered against the Counter Petitioner.

- 1 Cr.No. 25/2019 under sections 294(B), 323, 324, 427, 506(ii) IPC r/w 34 IPC, dated 29-03-2019 of Muthialpet Police Station, Puducherry Pending Trial.
- 2 Cr.No. 94/2019 under sections 120-B, 148, 341, 302, 109 IPC r/w 149 IPC, dated 08-12-2019 of Muthialpet Police Station, Puducherry – Pending Trial.

4. The Petitioner has also submitted that the Counter Petitioner is not a law abiding citizen and he has often violated the conditions imposed by the Court while he was released on bail. It is also stated that the Counter Petitioner have become a source of terror among the public and to meet expenses in connection with the trial in the pending criminal cases against him. It is further stated that he is very active notorious rowdy element and therefore, his criminal activities cannot be prevented by invoking the mere security proceedings under the Cr.P.C.

5. The Petitioner further submitted that if, Counter Petitioner is allowed to reside in Puducherry limits, it is apprehended that he would continue to indulge in serious offences like attempt to murder, hurt, damages, assault and thereby emerged as a perennial source of threat to the community and disturb public peace and order. Hence, the Station House Officer, Muthialpet Police Station, Puducherry, has prayed to invoke provisions under section 144 of Cr.P.C. against the Counter Petitioner do not to enter into the jurisdiction of this Court for a period of two months as to prevent danger to the human life and properties and disturbance to the public tranquility and order;

6. The proceeding was started by affording an opportunity to the Counter Petitioner to show cause against the petition filed by the Petitioner. A notice was served to both the parties on 10-02-2021 to appear for the hearing on 18-02-2021 at 11.00 a.m. It was instructed to serve the notice to the Counter Petitioner through the Station House Officer, Muthialpet Police Station, Puducherry. During the course of enquiry on 18-02-2021, both the Petitioner and Counter Petitioner were called absent. Hence, petition dismissed for default due to absence of Petitioner.

7. On 01-03-2021, the Station House Officer, Muthialpet Police Station, Puducherry, filed a restoration petition. A notice was served to both the parties on 01-03-2021 to appear for the hearing on 03-03-2021 at 11.00 a.m. It was instructed to serve the notice to the Counter Petitioner through the Station House Officer, Muthialpet Police Station, Puducherry. The notice for the Counter Petitioner was received by his sister, S. Snega. The service was held sufficient for the Counter Petitioner.

8. On 03-03-2021, the Petitioner Thiru G. Kalaiarasan, Sub-Inspector, Muthialpet Police Station, Puducherry, present. The Counter Petitioner has failed to appear before the Court on hearing date.

9. I have heard the Petitioner and carefully gone through all the available records placed before me. In the Police Information Report/Petition, it is stated that the activities of Thiru Sathish is in such a manner that they may cause breach of peace and create a problem of law and order and public tranquility. He has involved in crimes such as murder, assault, unlawful activities and disturbance to the public peace and order. There are 2 criminal cases registered against him in Muthialpet Police Station from 2019 onwards. All 2 cases are pending trial before the Hon'ble Courts.

10. On perusal of the records submitted by the Petitioner, I am of the opinion that if, the Counter Petitioner is allowed to reside within the limits of my jurisdiction, Counter Petitioner will continue to indulge in and also motivate serious offences like murder, assault, annoyance, damages to properties, *etc.*, and thereby become a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence it is necessary that special provision under section 144 of Cr.P.C. is invoked to take action against the Counter Petitioner to prevent harm to life and properties of citizens and uphold public peace and order;

Hence, I, M. Kandasamy, do hereby, in the capacity of Subdivisional Magistrate (North), Puducherry, in exercise of powers conferred under the section 144(1) of the Code of Criminal Procedure, pass this order and prohibit the Counter Petitioner Thiru Sathish, s/o. Sivakumar, a resident of No. 24, Maravady Street, Kurusukuppam, Muthialpet, Puducherry, from entering into the region under the jurisdiction of the Subdivisional Magistrate Court (North) for a period of two months from the date of this Order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry. However, you may represent against this order before the undersigned by post or by Counsel.

9. I have heard both the sides and carefully gone through all the available records in file placed by the Petitioner. In the Police Information Report/Petition, it is stated that the activities of Thiru. Anbalagan @ Alagar is in such a manner that they may cause breach of peace and create a problem of law and order and public tranquility. He has involved in crimes such as murder, assault, unlawful activities and disturbance to the public peace and order. There are 10 criminal cases were registered against him in various Police Stations. I have also heard the oral submission of the Counter Petitioner. The Counter Petitioner has stated that the Petitioner has filed this false case with an ulterior motive.

10. Up on hearing both sides and on perusal of the records submitted by the Petitioner, I am of the opinion that if the Counter Petitioner is allowed to reside within the limits of my jurisdiction, Counter Petitioner will continue to indulge in and also motivate serious offences like murder, assault, damages to properties, *etc.*, and thereby become a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C. is invoked to take action against the Counter Petitioner to prevent harm to life and properties of citizens and uphold public peace and order;

Hence, I, M. Kandasamy, do hereby, in the capacity of Subdivisional Magistrate (North), Puducherry in exercise of powers conferred under the section 144(1) of the Code of criminal procedure, pass this order and prohibit the counter petitioner Thiru Anbalagan @ Alagar, son of Seenuvasan, a resident of No. 69, Middle Street, Pooranankuppam, Thavalakuppam, Puducherry, from entering into the region under the jurisdiction of the Subdivisional Magistrate Court (North), for a period of two months from the date of this order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry. However, you may represent against this order before the undersigned by post or by counsel.
