ORDER

(UNDER SECTION 144 OF Cr.P.C.)

To

Puducherry.

Whereas, it has been made to appear to me that you have trivial and scant respect to the Judiciary and rule of law and are involved in various offences against public tranquility, offences affecting property and human body and that you have become a perennial source of threat to the community, public peace and order;

And whereas, I am convinced of your involvement in various criminal cases under (1) Cr.No. 243/2016 under sections 294(b), 324, 506(ii) r/w 34 IPC, dated 16-10-2016, (2) Cr.No. 82/2017 under section 25 (1-A) of Arms Act, dated 18-05-2017, (3) Cr.No. 490/2020 under sections 341, 302 IPC r/w 34 IPC @ 148, 341, 302 IPC r/w 149 IPC, dated 16-08-2020 of Villianur Police Station, Puducherry and your vengeful acts along with your accomplices against your opponents have created panic in the minds of the people;

And whereas, the Station House Officer, Villianur Police Station, Puducherry, has filed a case against you *vide* IR. No. 75/2021 under section 144 of Cr.P.C., dated 08-03-2021. It is stated by the Station House Officer, Villianur Police Station, Puducherry, that you are indulging in crime such as murder, rioting, hurt and Arms Act, damages to public property and disturbance to the public tranquility and order, and you have created panic in the minds of local inhabitants. It is also stated that you have become a source of terror among the public. As a result the people of the locality being afraid of you and do not come forward to lodge any complaint against you. It is also stated that even witnesses don't come forward voluntarily to give evidence against you in the cases where you are the accused;

And whereas, the Station House Officer, Villianur Police Station, Puducherry, further submitted that if, you are allowed to reside in the Subdivisional Magistrate (South) Jurisdiction limits, it is apprehended that you would continue to indulge in serious offences like hurt, criminal intimidation, rioting, damages to public and private property and disturbance to the public tranquility and order, *etc.*, and thereby emerged as a perennial source of threat to the community and, disturb public peace and order;

And whereas, summons were served for your appearance on 18-03-2021 to file your explanation/objection as to why the Subdivisional Magistrate (South), Villianur, Puducherry, should not order to prevent you from entering into the south region under section 144 (3) of Cr.P.C. You have failed to appear before the Court to put forth your side;

And whereas, based on the report laid before me, I am of the opinion that if, you are allowed to reside within the limits of this jurisdiction, you will continue to indulge in and also motivate serious offences and thereby become a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C. is invoked to take action against you to prevent harm to life and properties of citizens and uphold public peace and order.

And, whereas, I am satisfied that in view of the ensuing General Elections to the Puducherry Legislative Assembly, wherein, it necessitates to maintain law and order for peaceful and fair elections and that your activities will endanger human life and properties and your presence is a threat to public tranquility in Puducherry District and therefore, an immediate action is required for curtailing your illegal activities in the locality;

Now, therefore, based on the reasons stated above, I, K. Muralidharan, Subdivisional Magistrate (South), Villianur, in exercise of powers conferred under Code of Criminal Procedure, do hereby prohibit you under section 144 of Cr.P.C. from entering into the region under the jurisdiction of Subdivisional Magistrate Court (South) for a period of one month from the date of this order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier, except when you are summoned to attend the cases in any of the Courts in Puducherry.
