NOTIFICATION

Whereas, the Government is of the opinion that an industrial dispute has arisen between the management of M/s. UCAL Fuel Systems Limited, Puducherry and the Union workmen, represented by UCAL Employees Union, Puducherry, over transfer of employees listed in the Annexure-I, from Puducherry to Maraimalai Nagar, Chennai Unit and Annexure-II, from Puducherry to Bawal, Haryana Unit, lock-out declared during the pendency of conciliation proceedings, insisting up on the individual workmen to sign good behavior

Undertaking Bond as a pre-condition to allow them to resume work for lifting the lock-out amounting to unfair labour practice and removal of machineries without adhering to the provisions envisaged under the Industrial Disputes Act, 1947, in respect of the matter mentioned in the Annexure to this order:

And whereas, in the opinion of the Government, it is necessary to refer the said dispute for adjudication;

Now, therefore, by virtue of the authority delegated *vide* G.O. Ms. No. 20/91/Lab./L, dated 23-05-1991 of the Labour Department, Puducherry, to exercise the powers conferred by clause (c) of sub-section (1) of section 10 of the Industrial Disputes Act, 1947 (Central Act XIV of 1947), it is hereby directed by the Secretary to Government (Labour) that the said dispute be referred to the Labour Court, Puducherry, for adjudication.

The Labour Court, Puducherry, shall submit the Award within 3 months from the date of issue of reference as stipulated under sub-section 2-A of section 10 of the Industrial Disputes Act, 1947 and in accordance with Rule 10-B of the Industrial Disputes (Central) Rules, 1957. The party raising the dispute shall file a statement of claim complete with relevant documents, list of reliance and witnesses to the Labour Court, Puducherry, within 15 days of the receipt of the order of reference and also forward a copy of such statement to each one of the opposite parties involved in the dispute.

- 4. Children's Educational Allowance: The Officer shall be entitled either to claim the Children's Education Allowance from the State Government as laid down in para.1(a) of Finance Ministry's O.M.
