In exercise of the powers conferred under sub-section (2) of section 22 of the Biological Diversity Act, 2002 (Central Act 18 of 2003), read with the National Biodiversity Authority as specified by Central Government in OM.No. CS-C12017/6/201/-CS.III, dated 30-12-2019 of the Ministry of Environment, Forest and Climate Change, the Lieutenant-Governor, Puducherry, is pleased to constitute the Puducherry Biodiversity Council to implement the provisions of the Biological Diversity Act, 2002 for function in respect of the following subjects:

(a) Regulating access to biological resources for commercial utilization as specified under section 7 of the Biological Diversity Act, within their Jurisdiction;

(b) Supervising the formation and functioning of Biodiversity Management Committees (BMCs) and preparation of People's Biodiversity Registers (PBRs);

Terms and Conditions of Puducherry Biodiversity Council

(a) The term of office of the non-official members of the Puducherry Biodiversity Council shall be for a period of three years from the date of issue of the order by the Union territory of Puducherry Administration.

(b) The Office of the Puducherry Biodiversity Council shall function at the Directorate of Forests and Wildlife, Puducherry.

(c) The Council shall function as per the provisions of the Biological Diversity Act, 2002 (Central Act 18 of 2003) and the Biological Diversity Rules, 2004.

(d) The Union territory of Puducherry Administration shall constitute a fund which shall be known as the "Puducherry Biodiversity Council Fund" and all the fees, charges and benefit sharing amount received by the Council shall be credited to it. The amount so received in the "Puducherry Biodiversity Council Fund" shall be used only for the purposes mentioned in Section 27 (2) of the Biological Diversity Act, 2002.

(e) The Administrative expenses towards the functioning of the Council shall be borne by the Union territory of Puducherry Administration.

(f) The Council shall perform the functions within the Jurisdiction of the Union territory of Puducherry as has been vested to the State Biodiversity Boards under various provisions of the Biological Diversity Act.

(g) The Council shall in consultation with National Biodiversity Authority notify the format and procedures for seeking approval as required under Section 7 of the Act.

(h) The Puducherry Biodiversity Council shall come into existence from the date of issue of this Order.

(i) If, any difficulty arises in giving effect to the provisions of this Notification, the National Biodiversity Authority may, by order, not inconsistent with the provisions of the Biological Diversity Act, remove the difficulty.

NOTIFICATION

Whereas, the Government of India, Ministry of Fisheries, Animal Husbandry and Dairying, Department of Fisheries *vide* Order No. 30035/15/97-FY(T-1)VOL.V, dated 30-03-2021 has instructed to impose a uniform ban on fishing by all fishing vessels in the Indian Exclusive Economic Zone beyond territorial water on the East Coast and West Coast for the year 2021 for conservation and effective management of Fishery resources and also for sea safety reasons;

2. And whereas, in consonance with the above direction and in exercise of the powers conferred under section 4 (1) (a) read with section 4 (2) (a) & (b) of the Puducherry Marine Fishing Regulation Act, 2008 (Act No. 6 of 2008), in regard to the need to conserve marine fishery wealth and to regulate fishing on a scientific basis, the Lieutenant-Governor, Puducherry, implements this ban period in the territorial waters of the Union territory of Puducherry;

3. Now, further, the Lieutenant-Governor, Puducherry, is pleased to authorize the Secretary to Government (Fisheries) to prohibit the fishing activities within the territorial waters of the Union territory of Puducherry by issuing Notices in the local newspapers on imposition of the above ban on fishing on the region specified in Column (2) of the below Table by class of fishing vessels mentioned in Column (3) during the period specified in Column (4) of the Table given below:-
