ORDER

The Directorate of Survey and Land Records, Puducherry, has digitalized the Land Records in the Union territory of Puducherry in collaboration with NIC, Puducherry, using the NILAMAGAL Software and has been issuing computerized extracts of Land Records viz., Patta Copy, Settlement Copy and FMBs through the Common Service Centres located across the Union territory of Puducherry.

2. Even though the digitized records are made available through Common Service Centres, the general public have to approach the Common Service Centres for obtaining such land Records. Therefore, in order to up-scale the e-Services as well as to ease the accessibility of such records by the general public such digitized land records are presently made available in "Public Domain" through www.nilamagal.py.gov.in. This will enable the general public to view as well as to take printout of the certified digitized Settlement Extracts, FMB and Patta Copies anywhere 24 X 7 through their mobile phone and computer systems. For extending such e-Services of obtaining digitally signed printout of the Land Records, it is proposed to collect an user charge of ₹ 50 per copy.

3. Sanction of the Hon'ble Lieutenant-Governor, is hereby accorded to collect an user charge of ₹ 50 per copy that are made available in the public domain.

4. This order shall come into force with immediate effect and is issued with the concurrence of the Finance Department vide I.D.No. 3398/FC/F4/A3/2021-22, dated 23-7-2021.

3. The intending tenderers should deposit an amount of ₹ 5,000 (Rupees five thousand only) as earnest money deposit by cash. The earnest money deposit of the unsuccessful tenderers will be returned immediately after the tender sale is over.

4. Tenders received after the due date and time will summarily be rejected.

5. The successful tenderer should pay the entire amount and clear the items within 24 hours at his/her own risk and cost, failing which the earnest money deposit will be forfeited

6. The intending tenderers may inspect the condemned furniture and other items during office hours on any working day with prior permission of the concerned Headmasters in the above Schools without any disturbance to the students. The quantities and qualities are in as-is-where-is condition.

7. No claim on the quality and quantity of the articles will be admitted once the tender is finalized.
