#### **NOTIFICATION**

Whereas, the use of Aadhaar as an identity document for delivery of services or benefits or subsidies simplifies the Government delivery processes, brings in transparency and efficiency, and enables beneficiaries to get their entitlements directly in a convenient and seamless manner by obviating the need to produce multiple documents to prove one's identity;

2. And whereas, the Department of Civil Supplies and Consumer Affairs, Puducherry (hereinafter referred to as the Department/Implementing Agency), notified the following Schemes (hereinafter referred to as the Schemes), as amended from time to time:

#### Sl. No. Name of the Scheme

- (a) The distribution of sugar during Deepavali festival/Onam festival at Free of Cost to all the Ration Card holders of Puducherry, Karaikal, Mahe and Yanam regions, notified on 27-10-2009 by the Government of Puducherry.
- (b) The Puducherry free supply of rice, edible oil and other essential food-grains every month to all Ration Card holders, notified on 04-07-2016 by the Department of Civil Supplies and Consumer Affairs, Puducherry.
- (c) Food subsidy under National Food Security Act, 2013 notified on 17-01-2018.
- (d) Distribution of Festival items at free of cost to all the BPL/AAY Ration Card holders of Union territory of Puducherry, notified on 30-01-2018 by the Government of Puducherry.
- 3. And whereas, under the Schemes, the benefits are extended to eligible beneficiaries by the Implementing Agency as per the extant norms/fund availability;
- 4. And whereas, the aforesaid Schemes at para 2 above involve recurring expenditure incurred from the Consolidated Fund of Union territory of Puducherry/ the Consolidated Fund of India.
- 5. Now, therefore, in pursuance of section 7 of the Aadhaar (Targeted Delivery of Financial and other Subsidies, Benefits and Services) Act, 2016 (18 of 2016) (hereinafter referred to as the said Act), the Government of Union territory of Puducherry hereby notifies the following, namely:-
  - (i) An individual eligible for receiving the benefits under the Scheme shall hereby be required to furnish proof of possession of the Aadhaar number or undergo Aadhaar authentication.
  - (ii) Any individual desirous of availing benefits under the Scheme, who does not possess the Aadhaar number or, has not yet enrolled for Aadhaar, shall be required to make application for Aadhaar enrolment before registering for the Scheme provided that he is entitled to obtain Aadhaar as per section 3 of the said Act, and such individuals shall visit any Aadhaar Enrolment Centre (list available at the Unique Identification Authority of India (UIDAI) website www.uidai.gov.in) to get enrolled for Aadhaar.
  - (iii) As per regulation 12 of the Aadhaar (Enrolment and Update) Regulations, 2016, the Department through its Implementing Agency, is required to offer Aadhaar enrolment facilities for the beneficiaries who are not yet enrolled for Aadhaar and in case, there is no Aadhaar Enrolment Centre located in the respective Block or Taluka or Tehsil, the Department through its Implementing Agency shall provide Aadhaar enrolment facilities at convenient locations in coordination with the existing Registrars of UIDAI or by becoming a UIDAI Registrar themselves:

Provided that till the time Aadhaar is assigned to the individual, benefits under the Scheme shall be given to such individual, subject to the production of the following documents, namely:—

- (a) If, he has enrolled, his Aadhaar Enrolment Identification slip and
- (b) Anyone of the following documents, namely:-
  - (i) Bank or Post Office Passbook with Photo; or
  - (ii) Permanent Account Number (PAN) Card; or .
  - (iii) Passport; or
  - (iv) Family Ration Card; or
  - (v) Voter's Identity Card; or
  - (vi) Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) Card, or
  - (vii) Kisan Photo Passbook, or
  - (viii) Driving Licence issued by the Licensing Authority under the Motor Vehicles Act, 1988 (59 of 1988); or
  - (ix) Certificate of Identity having photo of such person issued by a Gazetted Officer or a Tahsildar on an official letterhead; or
  - (x) Any other document as specified by the Department.

Provided further that the above documents may be checked by an officer specifically designated by the Department for that purpose.

- 6. In order to provide benefits to the beneficiaries under the Schemes conveniently, the Department through its Implementing Agency shall make all the required arrangements to ensure that wide publicity through the media shall be given to the beneficiaries to make them aware of the said requirement.
- 7. In all cases, where Aadhaar authentication fails due to poor biometrics of the beneficiaries or due to any other reason, the following remedial mechanisms shall be adopted, namely:-
  - (a) in case of poor fingerprint quality iris scan or face authentication facility shall be adopted for authentication, thereby the Department through its Implementing Agency shall make provisions for iris scanners or face authentication along with finger-print authentication for delivery of benefits in seamless manner;
  - (b) in case the biometric authentication through fingerprints or iris scan or face authentication is not successful, wherever feasible and admissible authentication by Aadhaar One Time Password or Time- based One-Time Password with limited time validity, as the case may be shall be offered;
  - (c) in all other cases, where biometric or Aadhaar One Time Password or Time-based One-Time Password authentication is not possible, benefits under the Scheme may be given on the basis of physical Aadhaar letter whose authenticity can be verified through the Quick Response (QR) Code printed on the Aadhaar letter and the necessary arrangement of QR Code reader shall be provided at the convenient locations by the Department through its Implementing Agency.
- 8. In addition to the above, in order to ensure that no *bona fide* beneficiary under the Scheme is deprived of his due benefits, the Department through its Implementing Agency shall follow the exception handling mechanism as outlined in the Office Memorandum of DBT Mission, Cabinet Secretariat, Government of India, dated 19th December 2017.

- 2. The instructions issued by the Hon'ble Lieutenant-Governor for the sustained functioning of the Educational Institutions are communicated hereunder for strict compliance:
  - (i) It should be the endeavour of the Governing Body to transform the Institutions into "Centres of Excellence" of Medical Education and provide quality medical care to the patients. Decisions should be in the larger interest of the developing the Institutions to become self-sustaining and less dependent on Government grants.
  - (ii) In the event of engagement of manpower, the Institutions shall make appointments to all posts starting from the Director down to all posts strictly as per the Recruitment Rules notified duly meeting the age, educational qualification and experience criteria. The appointments shall be made through transparent process and open call. Such appointments shall also be restricted to the essential posts of Professors/Assistant Professors/Nurses and Technicians. No engagements should be made for generic works such as Sanitation, Multi-tasking, Drivers, etc., which shall be outsourced as per GFR provisions.

- (iii) The Governing Body shall do all that is possible to give a new direction to the management of the Institutions to transform them into "Institutions of repute" so much so that it attracts students willing to pay deserving fees and earns the trust of public as Institutions that provide quality medical care.
