#### **AWARD**

This Industrial Dispute arises out of the reference made by the Government of Puducherry *vide* G.O. Rt. No.142/AIL/Lab./T/2019, dated 30-12-2019 of the Labour Department, Puducherry, to resolve the following dispute between the petitioner and the respondent, *viz.*,–

- (i) Whether the dispute raised by the Union workmen represented by PIMS Maruthuvamanai Uzhiyargal Sangam (CITU), Puducherry, against the management of M/s. Puducherry Institute of Medical Sciences, Kalapet, Puducherry, over charter of demands such as to revise the wages by 50% Annual Increment by 20% to encash the leave at credit at the end of the year and other allowances, etc., are justified or not? If justified, what relief the Union workmen are entitled to?
- (ii) To compute the relief if, any awarded in terms of money if, it can be so computed?
- 2. Today, when the case came up for hearing, for petitioner notice returned as 'unclaimed', already two times the notices for petitioner returned as unclaimed, hence, this reference is closed as petitioner not appeared.
