Whereas, it has been made to appear to me that you have trivial and scant respect to the judiciary and rule of law and are involved in various offences against public tranquility, offences affecting property and human body and that you have become a perennial source of threat to the community, public peace and order;

And whereas, I am convinced of your involvement in various criminal cases under –

1. Cr.No. 118/2020 under section 379 IPC r/w 34 IPC of Mangalam Police Station, Puducherry, dated 09-06-2020.
2. Cr.No. 80/2021 under section 307 r/w 34 IPC and 4 of Explosive Substances Act, 1908 of Mangalam Police Station, Puducherry, dated 28-06-2021.

and your vengeful acts along with your accomplices against your opponents has created panic in the minds of the people;

And whereas, the Station House Officer, Mangalam Police Station, Puducherry, has filed a case against you *vide* IR.No. 109/2021 under section 144 of Cr.P.C., dated 29-09-2021. It is stated by the Station House Officer, Mangalam Police Station, Puducherry, that you are indulging in crime such as communal clash, rioting, attempt to murder, intimidation, theft and disturbance to the public tranquility and order and you have created panic in the minds of local inhabitants. It is also stated that you have become a source of terror among the public. As a result, the people of the locality being afraid of you and do not come forward to lodge any complaint against you. It is also stated that even witnesses don't come forward voluntarily to give evidence against you in the cases where you are the accused;

And whereas, the Station House Officer, Mangalam Police Station, Puducherry, further submitted that if, you are allowed to reside in Subdivisional Magistrate (South) Jurisdiction limits, it is apprehended that you would continue to indulge in serious offences like communal rioting, murder, attempt to murder, robbery and dacoits, damages to public and private properties, assault, obstructions, annoyance and disturbance to the public tranquility and order, *etc.*, and thereby emerged as a perennial source of threat to the community and disturb public peace and order;

And whereas, summons were served for your appearance on 18-10-2021 and 17-12-2021 to file your explanation/objection as to why the Subdivisional Magistrate (South), Villianur, Puducherry, should not order to prevent you from entering into the south region under section 144 (3) of Cr.P.C., and you failed to appear before this Court and hence, the case is decided *ex parte* under section 144(2) of Cr.P.C., in the view of urgency of the matter;

And whereas, based on the report laid before me, I am of the opinion that if, you are allowed to reside within the limits of this jurisdiction, you will continue to indulge in and also motivate serious offences and disturbance to the public tranquility and order, *etc.*, and thereby become a perennial source of threat to the community and disturb public peace and order.
