- (e) Hear appeals against orders of the District Grievance Redressal Officer.
- (f) Prepare annual reports which shall be laid before the State Legislature by the State Government.
- 3. The service conditions of the Food Commission of the Union territory of Puducherry are detailed in the Puducherry Food Security Rules, 2017.
- 4. The tenure of the Committee shall be for a period of one year from the date of issue of this notification.

Whereas, an order was made vide reference cited, directing the winding up of the affairs of the Soundararaja Mills Employees' Co-operative Credit Society Limited, No. P. 353 (for brevity "the society");

(2) And whereas, consequent to the winding up of the society, a Liquidator is to be appointed under sub-section (1) of section 127 of the Puducherry Co-operative Societies Act, 1972 (for brevity "the Act"),

in consultation with the financing Bank, to carry out the liquidation processes for cancelling the registration of the Society;

Whereas, the Government is of the opinion that an industrial dispute has arisen between the management of M/s. Hindustan Unilever Limited, Tea Factory, Kirumampakkam, Puducherry and Thiru R. The party raising the dispute shall file a statement of claim complete with relevant documents, list of reliance and witnesses to the Labour Court, Puducherry, within 15 days of the receipt of the order of reference and also forward a copy of such statement to each one of the opposite parties involved in the dispute.
