And Whereas, I am convinced of your involvement in various criminal cases under;

And whereas, the Station House Officer, Dhanvantri Nagar Police Station has filed a case against you through the Superintendent of Police (North) *vide* IR.No. 02/2021 under sections 144 of Cr.P.C, dated 05-01-2021. It is stated by the Station House Officer, Dhanvantri Nagar Police Station that you have formed a gang of rowdies and bent up on indulging in crime such as attempt to murder, extortion, obstructions, annoyance, damages to public and private properties and disturbance to the public tranquility and order, and you have created panic in the minds of local inhabitants and the farmer business community in the rural limit. It is also stated that you have become a source of terror among the public. As a result the people of the locality being afraid of you and do not come forward to lodge any complaint against you. It is also stated that even witnesses don't come forward voluntarily to give evidence against you in the cases where you are the accused;

And whereas, it is also stated that you are hatching plans to threaten the business people in the Puducherry area and extort money from them by threatening, but the public do not come forward to lodge any complaint against you due to fear. It is further stated that you are involving in various offences by using aruval, knife and explosive substances to attack the victims. You also violated the conditions imposed by the Criminal Courts and have scant respect to the Judiciary and Rule of law;

And whereas, the Station House Officer, Dhanvantri Nagar Police Station, Puducherry, further submitted that if, you are allowed to reside in Dhanvantri Nagar limits, it is apprehended that you would continue to indulge in serious offences like murder, extortion, damages to public and private properties, assault, obstructions, annoyance, *etc.*, and thereby emerged as a perennial source of threat to the community and disturb public peace and order. Hence, the Station House Officer, Dhanvantri Nagar Police Station, has prayed to invoke provisions under section 144 of Cr.P.C. against you not to enter into the jurisdiction of this Court for a period of two months as to prevent danger to the human life and properties, and disturbance to the public tranquility and order;

And whereas, based on the report laid before me, I am of the opinion that if, you are allowed to reside within the limits of my jurisdiction, you will continue to indulge in and also motivate serious offences like murder, extortion, hurt, assault, damages to public and private properties, obstructions, annoyance, *etc.*, and thereby become a perennial source of threat to the community and disturb public peace and order.
