### IN THE COURT OF THE SUBDIVISIONAL MAGISTRATE (SOUTH) AT VILLIANUR

Present: Thiru Dr. R. GIRI SANKAR, I.A.S., Subdivisional Magistrate (South).

M.C. No. 194/2021, I.R.No. 37/2021 under section 144 of Cr.P.C./1133

#### **ORDER**

(UNDER SECTION 144 OF Cr.P.C.)

To

Thiru Rajkumar (22), S/o. Rusthan, No.3, Madha Koil Street, Thuthipet, Puducherry.

Whereas, It has been made to appear to me that you have trivial and scant respect to the judiciary and rule of law, and are involved in various offences against public tranquility, offences affecting property and human body and that you have become a perennial source of threat to the community, public peace and order;

And whereas, I am convinced of your involvement in various criminal cases under (1) Cr.No. 170/2020 under sections 364, 342, 302, 212, IPC r/w IPC of Mettupalayam Police Station, Puducherry, (2) Cr.No. 160/2019 under sections 286, 338, IPC r/w 34 IPC and 3 and 4 of Explosive Substances Act, 1908 of Villianur Police Station, Puducherry and Transferred to Sedarapet Police Station, Puducherry, (3) Cr.No. 26/2020 under section 380 IPC, dated 16-05-2020 of Sedarapet Police Station, Puducherry and your vengeful acts along with your accomplices against your opponents have created panic in the minds of the people;

And whereas, the Station House Officer, Sedarapet Police Station, Puducherry, has filed a case against you *vide* IR.No. 37/2021 under section 144 of Cr.P.C., dated 11-06-2021. It is stated by the Station House Officer, Sedarapet Police Station, Puducherry, that you are indulging in criminal activities causing disturbance to the public tranquility and order which have created panic in the minds of local inhabitants. Its is also stated that you have been extorting money from the business people in the Puducherry and Private Company labour contractors in rural area by threatening them and leading lavish life with the extorted money and it has become a source of terror among the public. As a result, the people of the locality being afraid of you and do not come forward to lodge any complaint against you. It is also stated that even witnesses don't come forward voluntarily to give evidence against you in the cases where you are the accused;

And whereas, the Station House Officer, Sedarapet Police Station, Puducherry, further submitted that if, you are allowed to reside in Subdivisional Magistrate (South) Jurisdiction limits, it is apprehended that you would continue to indulge in serious offences like murder, extortion, assault, explosion, damages to public and private property and disturbance to the public tranquility and order, *etc.*, and thereby emerged as a perennial source of threat to the community and disturb public peace and order;

And whereas, summon was served for your appearance on 30-06-2021, to file your explanation/objection as to why the Subdivisional Magistrate (South), Villianur, Puducherry, should not order to prevent you from entering into the south region under section 144 (3) of Cr.P.C., You have failed to appear before the Court to defend your side;

And whereas, based on the report laid before me, I am of the opinion that if, you are allowed to reside within the limits of this jurisdiction, you will continue to indulge in and also motivate serious offences and thereby become a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C. is invoked to take action against you to prevent harm to life and properties of citizens and uphold public peace and order;

Now, therefore, based on the reasons stated above, I, Dr. R. Giri Sankar, I.A.S., Subdivisional Magistrate (South), Villianur, Puducherry, in exercise of powers conferred under Code of Criminal Procedure, do hereby prohibit you under section 144 of Cr.P.C. from entering into the region under the jurisdiction of Subdivisional Magistrate Court (South), for a period of two months from the date of this order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry.
