NOTIFICATION

Whereas, the lands mentioned in the Schedule appended below have been notified for acquisition for the public purpose viz., Provision of play ground to Government High School, Uruvaiyar in Uruvaiyar Revenue Village, Puducherry;

And whereas, the notification under section 4(1) of the Land Acquisition Act was issued vide G.O. Ms. No. 98, dated 03-11-2006 and the declaration under section 6 of the Land Acquisition Act was issued vide G.O. Ms. No. 100, dated 30-10-2007 and the Award was passed vide Award No. 2/2010, dated 29-06-2010;

And whereas, the requisition Department *viz.*, Directorate of School Education, Puducherry, has identified an alternate Government Poramboke Land in the immediate vicinity of the School where the erstwhile residential quarters of Teachers existed and found to be more suitable for provision of play ground;

And whereas, approval of the Administrative Secretary has been obtained for withdrawal of acquisition of lands *vide* Order No. 640/DSE/SW/E8/2020, dated 14-02-2020 of the Directorate of School Education, Puducherry;

And whereas, the lands mentioned in the Schedule have not been taken possession;

And whereas, the Government of Puducherry, having satisfied that the lands specified in the Schedule were no more required for the purpose has decided to withdraw the acquisition proceedings;

Now, therefore, in pursuance of sub-section (1) of section 48 of the Land Acquisition Act, 1894 (Central Act 1 of 1894), the Lieutenant-Governor, hereby withdraws the acquisition proceedings initiated for lands in Re-Survey Nos. 59/2B/5B, 59/2B/6B and 59/9B/3 in Uruvaiyar Revenue Village as detailed in the Schedule hereunder.

Consequently, the notification under section 4(1) of the Land Acquisition Act, 1894 approved in G.O. Ms. No. 98, dated 03-11-2006 and published in the Official Gazette of Puducherry, No. 47, dated 21-11-2006 and the declaration under section 6 of the Land Acquisition Act, 1894, approved in G.O. Ms. No. 100, dated 30-10-2007 and published in the Official Gazette of Puducherry, No. 46, dated 13-11-2007 shall be treated as withdrawn in respect of the said lands mentioned in the Schedule hereunder:
