NOTIFICATION

The Government of Puducherry, Freedom Fighters Cell, Chief Secretariat, Puducherry, has been honouring the Freedom Fighters/Dependants on the occasion of Independence Day, De Jure Transfer Day and Gandhi Jayanthi Day by disbursing cash incentive along with the pension during the month of October every year. It has now been proposed to formulate a Scheme in the name "Integrated Disbursement of Cash Incentives Scheme" from the year 2021 and continuously by every year for the abovesaid purpose.

Objective.— To Disburse cash incentives to honour the Freedom Fighters/Dependants *in lieu of* clothes/gift coupons on account of Independence Day, De Jure Transfer Day and Gandhi Jayanthi Day which shall be disbursed alongwith the pension for the month of October every year.

Eligibility.— All the Freedom Fighters those who are living at present in all the four regions of this Union territory of Puducherry.

The spouse/dependants of the deceased Freedom Fighter in all the four regions of this Union territory of Puducherry.

All those who are drawing Central and State Freedom Fighters Pension in force from time to time.

Duration.— Once in every year during the month of October alongwith the disbursement of usual monthly pension payment.

Cash Incentive.— Live Freedom Fighters – ₹ 3,500 for Central and State Freedom Fighters.

Wife of deceased Freedom Fighters – ₹ 2,500 for Central and State Freedom Fighter Family Pensioners.

Beneficiaries.— Freedom Fighters and the spouse of the deceased Freedom Fighters of all the four regions of this Union territory of Puducherry only .

Disbursement.— The above incentive shall be transferred automatically by the Directorate of Accounts and Treasuries, Government of Puducherry, to the Bank account of the pensioner alongwith the pension during the month of October every year.

Fund Management.— The expenditure shall be debitible under the Head of Account, '2235' – Social Security and Welfare – 60 – other Social Security and Welfare Programmes – 60/107 SSS Pension Scheme – 60/107 (1) SSS Pension Scheme – 60/107(1) (1) Pondicherry Region – (50) Other Charges in the budget of the respective/concerned financial year.

Authority.— The Secretary to Government (Freedom Fighters Cell), Government of Puducherry, Chief Secretariat, Puducherry, shall be the Authority for the implementation of the abovesaid Scheme.
