The tenders will be opened at 4.00 p.m. on the same day, in the presence of the tenderers, in the office of the undersigned at the Office of the Superintending Engineer-I, Puducherry.

3. If necessary, the public auction will be conducted among the tenderers based on the highest quotations on the sealed tenders to fix the highest rate.

4. The intending tenderers/bidders should deposit an amount of ₹ 300 (Rupees three hundred only) as earnest money deposit. Tenderers/bidders should have a copy of any valid I.D. and address proof along with GST Particulars.

5. The earnest money deposit of the unsuccessful tenderers/bidders will be refunded immediately soon after the tenders auction sale is over. Tenderers/bidders should produce valid I.D. proof for returning their earnest money deposit amount.
