Whereas, the managements of M/s. JR Cinemas, M/s. Rathnaa Talkees, M/s. Shanmuga Cinemas, M/s. Murugaa Theatre, M/s. Ashok Theatre A/C, M/s. Balaji Theatre and M/s. Raja Talkies A/C, Puducherry, have applied for grant of exemption from certain provisions of the Puducherry Shops and Establishments Act, 1964, to conduct special morning shows on account of screening new films;

Whereas, the Lieutenant-Governor, Puducherry, has by Notification in G.O. Ms. No. 9/95/Lab., dated 07-04-1995 under sub-section (1) of section 52 of the Puducherry Shops and Establishments Act, 1964, authorized the Secretary to Government, Labour Department, Puducherry, to exercise the powers of the Government under section 6 of the said Act, relating to exemption;
