NOTIFICATION

Whereas, the management of M/s. The Cinema Providence, Providence Mall, Puducherry, have applied for grant of exemption from certain provisions of the Puducherry Shops and Establishments Act, 1964, to conduct special morning shows on account of screening new films;

Whereas, the Lieutenant-Governor, Puducherry has by Notification in G.O. Ms. No. 9/95/Lab., dated 07-04-1995 under sub-section (1) of section 52 of the Puducherry Shops and Establishments Act, 1964, authorized the Secretary to Government, Labour Department, Puducherry, to exercise the powers of the Government under section 6 of the said Act, relating to exemption;

Now, therefore, in exercise of the powers conferred by section 6 of the said Act, the Secretary to Government, Labour Department, Puducherry, hereby exempts M/s. The Cinema Providence, Providence Mall, Puducherry, from the provisions of the sections 16(1), 17(1), 17(2) and 18 of the Pondicherry Shops and Establishments Act, 1964, for conducting special morning free shows as per Table below:

The conduct of the special shows shall be subject to the following conditions:

1. Every person employed shall be paid overtime wages for the period of work done by him in excess of 8 hours in a week.

2. The persons employed shall be given rest interval of atleast half-an-hour for every four hours of work.

3. The management should obtain permission from the authorities concerned wherever necessary.

4. In case, the said screening of the new film does not take place this Notification shall have no effect.

5. The SOPs issued in respect of COVID-19 like wearing of mask and other conditions issued by the Department of Revenue and Disaster Management, Puducherry, shall be strictly adhered to.

The tenders in sealed cover should be addressed to the Block Development Officer, Villianur, Puducherry-605 110, duly superscribing on the envelope as "Tender for the purchase of e-waste items" and to reach the undersigned on or before 11-05-2022 at 3.30 p.m. The received tenders will be opened on the same day at 4.00 p.m. in the presence of the tenderers or their representatives who are present at that time. If, the opening day of the tenders happens to be a public holiday, the same will be opened on the next working day.

The intending tenderers (Puducherry Pollution Control Committee authorized e-waste recyclers) should deposit a sum of ₹ 2,000 (Rupees two thousand only) in cash as earnest money deposit at the time of submitting their tenders. The earnest money deposit of the unsuccessful tenderers will be refunded after finalization of the tenders.

4. Tenders received after the due date and time will be rejected. The highest rate quoted in the tenders will be minimum price and then the open auction will be conducted on the same day. In the open auction, the tenderers who have already submitted sealed tenders will only be allowed.

5. The successful tenderer/bidder should pay the entire amount immediately along with the prevailing GST, and clear all the items within 24 hours at his/her own risk, failing which the earnest money deposit will be forfeited and remitted into the Government Account. The successful tenderer/bidder should make his/her own arrangements to clear the said items.

6. The undersigned reserves the right to accept or reject any tenders or all of them without assigning any reason thereof.

7. No claim on the quantity and quality of the old/condemned and unserviceable articles will be admitted once the tender/bid is finalized.

8. The intending tenderer can inspect the old articles during office hours on all working days.
