**NOTIFICATION**

In exercise of the powers conferred under clause (r) of sub-section (2) of section 65 of the Puducherry Municipalities Act, 1973 (No. 9 of 1973) and of all other powers enabling her in this behalf, the Lieutenant-Governor, Puducherry, is hereby pleased to make the following rules further to amend the Puducherry Municipal Councils (Conduct of Election of Councillors) Rules, 1974, notified *vide* G.O. Ms. No. 210, dated 14th December 1974 of the Local Administration Department, Government of Puducherry, namely:-

1. *Short title, extent and commencement.*— (1) These rules may be called the Puducherry Municipal Councils (Conduct of Election of Councillors) [Third Amendment] Rules, 2022.

(2) They shall extend to the whole of the Union territory of Puducherry.

(3) They shall come into force with immediate effect.

2. *Amendment of Form 7.*— For the existing Form-7 appended to the Puducherry Municipal Councils (Conduct of Election of Councillors) Rules, 1974, the following 'Form-7' shall be substituted, namely:-

*Nota Bene (N.B.):*

1. Separate list for each Post shall be prepared.
2. List of candidates for all the posts shall be prepared in English and Regional Languages and shall be alphabetically (in regional language) listed out in the following order -
  - (a) Candidates of recognized National and State Political Parties First;
  - (b) Candidates of registered political parties (other than recognized National and State Political Parties) as second and;
  - (c) The candidates other than Political Parties as third position.
3. Under Column 1 above, the serial number of candidates of all the categories shall be given consecutively and not separately for each category.
