In exercise of the powers conferred under clause (r) of sub-scction (2) of section 38 of the Puducherry Village and Commune Panchayats Act, 1973 (No. 10 of 1973) and of all other powers enabling her in this behalf, the Lieutenant-Governor, Puducherry, is hereby pleased to make the following rules further to amend the Puducherry Village and Commune Panchayats (Conduct of Election of Members of Commune Panchayat Councils and Presidents and Members of Village Panchayats) Rules, 1978, notified *vide* G.O. Ms. No. 310, dated 11th December, 1978 of the Local Administration Department, Government of Puducherry, namely:-

1. Short title, extent and commencement.— (1) These rules may be called the Puducherry Village and Commune Panchayats (Conduct of Election of Members of Commune Panchayat Councils and Presidents and Members of Village Panchayats) [Third Amendment] Rules, 2022.

(2) They shall extend to the whole of the Union territory of Puducherry.

(3) They shall come into force with immediate effect.

2. Amendment of Form 6.— For the existing Form-6 appended to the Puducherry Village and Commune Panchayats (Conduct of Election of Members of Commune Panchayat Councils and Presidents and Members of Village Panchayats) Rules, 1978, the following 'Form-6' shall be substituted, namely:-
