No. CO-99/1/2022-PCP-HO-CPCB-HO.—In exercise of the powers conferred by Section 4, clause (4) of the Water (Prevention and Control of Pollution) Act, 1974 (Act No. 6 of 1974) and Section 6 of the Air (Prevention and Control of Pollution) Act, 1981 (Act No. 14 of 1981), the Central Pollution Control Board hereby reconstitutes the Committee as specified by the Central Government whose constitution was notified by a Notification published in the Gazette of India vide S.O.787 (E) dated 10.03.1992 in respect of the Union Territory (UT) of Puducherry. The reconstitution of the Committee is as follows:

And,

- (i) This Committee may be called as Puducherry Pollution Control Committee.
- (ii) This Committee shall exercise all the powers which were delegated to the Committee vide Principal Notification, S.O.787 (E), dated 10.03.1992.
- (iii) The Notification shall come into force with immediate effect.
- (iv) The Notification published in the Gazette of India vide S.O.787 (E), dated 10.03.1992 and S.O. 777 (E), dated 19.07.1995 stands rescinded.
