NOTIFICATION

Whereas, section 7 of the Central Aadhaar (Targeted Delivery of Financial and other Subsidies, Benefits and Service) Act, 2016 (hereinafter referred to as "the said Act"), provides that the State Government or, as the case may be, any Agency of the State Government, for the purpose of establishing identity of an individual as a condition for receipt of a subsidy, benefit for which the expenditure is incurred entirely by way of withdrawal from, or the receipt therefrom forms

part of the Consolidated Fund of the State/Central, can mandate such individual to undergo authentication, or furnish proof of possession of Aadhaar;

2. In the case of an individual to whom no Aadhaar number has been assigned, if, such individual makes an application for enrollment, the proviso to the said section 7 of the said Act provides that, till such time an Aadhaar number is not assigned to an individual, the individual shall be offered alternate and viable means of identification for delivery of the subsidy or benefit;

3. And whereas, the Government considers it expedient to notify the list of Schemes, for which such authentication or proof is required as per the said section for getting the benefits of said Scheme;

4. Now, therefore, the Government of Puducherry, in exercise of the power conferred by section 7 of the said Act, hereby notifies the list of Schemes and all components included therein from time to time of Department of Agriculture and Farmers Welfare, Puducherry mentioned in the Schedule 'A' appended hereto for which authentication or proof of identity specified in Schedule 'B' required as per said section for the purpose of establishing identity of an individual and also the Consent Form of the concerned beneficiary as specified in Schedule 'C' as a condition for receipt of the benefit of the said Scheme;

SCHEDULE 'B'**Authentication or Proofs of Identity**

1. Every individual desirous of availing benefits under the Schemes specified in Schedule 'A' are hereby required to furnish proof of possession of Aadhaar number or undergo Aadhaar authentication.

2. (i) Any individual desirous of availing benefits under the said Schemes, who is not yet enrolled for obtaining Aadhaar number shall have to enroll for obtaining Aadhaar number before submitting an application for the said Schemes, in case, he is entitled to obtain Aadhaar number as per the provisions of section 7 of the Aadhaar (Targeted Delivery of Financial and other Subsidies, Benefits and Services) Act, 2016 (10 of 2018). Such individuals may visit any Aadhaar enrollment camp in the vicinity wherein, Aadhaar enrollment is being facilitated by Registrars appointed by the Unique Identification Authority of India (UIDAI).

(ii) In case, individuals are not able to enroll due to non-availability of enrollment centres in their Village or Taluk, they may register their request for enrollment to Department's designated Field Offices or any web portal specified by the Department.

3. Till the time, Aadhaar number is assigned to the eligible individual benefits under the said Schemes shall be given to the eligible individual subject to the production of the following alternate and viable means of identification, namely:—

(i) Aadhaar enrollment ID Slip if, he/she had enrolled or copy of the request made for Aadhaar enrollment, as specified in sub-paragraph (i) of paragraph 2 above along with any one of the following documents:

(a) The Elector's Photo Identity Card issued by the Election Commission of India;

(b) The Permanent Account Number (PAN) issued by the Income-tax Department; or

(c) The Passport; or

(d) The Family Ration Card issued by the Department of Civil Supplies and Consumer Affairs, Puducherry.

SCHEDULE 'C'

Beneficiary Consent Form Format

I agree to share my Aadhaar details (identity information) and other information with Government for the purpose of yes/no authentication with Unique Identification Authority of India (UIDAI). I give consent to the Department to seed my data into the data base, to make payment through D.B.T. and use it in the Welfare Schemes of Department of Agriculture and Farmers Welfare, Puducherry.
