NOTIFICATION

The Hon'ble Lieutenant-Governor of Puducherry, is pleased to enhance the age of superannuation of the Medical Officers in the Department of Indian System of Medicine and Homoeopathy from 60 years to 65 years with immediate effect on par with Central AYUSH Service *vide* the Notification No. GSR – 767(E), dated 11-08-2018 of the Department of Personnel and Training, New Delhi, subject to the following conditions:

(i) The age of superannuation of the Medical Officers shall ordinarily be 62 years. The Medical Officers desiring to continue in their service up to the age of 65 years shall exercise the prioritized option of posting under the categories of (1) Teaching, (2) Clinical, (3) Patient Care, (4) Implementation of Health Programmes, (5) Implementation of Public Health Programmes, (6) Advisory and (7) Consultancy, depending on the field of their experience and expertise, within 6 months before the date of attaining the age of 62 years (Option Form enclosed). The Appointing Authority may repost them as "Senior Chief Medical Officer" under anyone of the categories of posts to serve up to the age of 65 years, subject to availability of vacancy in the concerned field of posting and administrative convenience. Their other service conditions shall remain unaltered while serving as Senior Chief Medical Officer.

(ii) The Medical Doctors, who fail to exercise the option of posting within 6 months before the date of attaining the age of 62 years, shall be superannuated from their services on attaining the age of 62 years.

(iii) The Medical Officers can hold the administrative posts until they attaining the age of 62 years alone.
