## NOTIFICATION

The Fee Committee was originally constituted as per the orders of the Government of Puducherry in G.O. No. 63, dated 25-05-2006 of Chief Secretariat (Education), Puducherry, which has been ordered to continue to function as per G.O. No. 14, dated 06-03-2015 of Chief Secretariat (Education), Puducherry. The Fee Committee was reconstituted vide G.O. No. 13, dated 07-06-2021 of Chief Secretariat (Higher and Technical Education), Puducherry, under the Chairmanship of Mr. Justice T. Sudandiram, Judge (Retd.,), High Court of Madras.

2. The Fee Committee under the Chairmanship of Mr. Justice T. Sudandiram, Judge (Retd.,), High Court of Madras in its meeting held on 27-10-2021 and 28-10-2021, revised the fee structures for M.B.,B.S./B.D.S./B.Sc. Nursing/B. Pharm courses for three years with effect from 2021-2022 to 2023-2024.

3. The above was considered by Hon'ble Lieutenant-Governor and it was decided that, in the larger interest and the fact that the Medical Colleges had conducted classes in hybrid mode of online and offline, the continuation of the Fee fixed by the earlier Fee Committee for the academic year 2021-2022 may not be detriment of the Institutions, as well.

4. Accordingly, the Hon'ble Lieutenant-Governor, is pleased to order to continue with the fee fixed by the earlier Fee Committee and issued in G.O. Ms. No. 24, dated 03-07-2018 for admission of students in M.B.,B.S./B.D.S. courses, the Fee fixed in G.O. Ms. No. 51, dated 22-12-2020 for admission of students in B. Pharm. course and the Fee fixed in Order, dated 27-12-2018 for admission of students in B.Sc. Nursing course may be extended for the current year *i.e.*, 2021-2022, also subject to conditions as laid in the above-mentioned G.Os. and Order.
