This petition along with case sheet is filed by the Station House Officer, represented by Thiru C. Ilavarasan, Sub-Inspector of Police, Mudaliarpet Police Station, Puducherry, praying to pass orders under section 144 of Cr.P.C., against Counter Petitioner to prevent imminent danger to human lives and properties, and disturbance to the public tranquility and order, in the jurisdiction of this Court.

- 2. The Counter Petitioner is Thiru Pugazh (21), son of Ezhumalai, a resident of No. 48, Velrampet, Erikarai Street, Mudaliarpet, Puducherry.
- 3. The facts which led up to the petition are briefly as follows: The case submitted by the Sub-Inspector of Police, Mudaliarpet Police Station, Puducherry, with the recommendation of Superintendent of Police (South), Puducherry vide I.R. No. 150/2021, under section 144 of Cr.P.C, dated 24-09-2021. Therein, it has been stated that the Counter Petitioner have involved in crime such as hurt and disturbance to the public tranquility and order. The Counter Petitioner has created panic in the minds of local inhabitants and the business people in the city limits. It is also stated that he is leading lavish life with the money earned through extortion. The Petitioner has also submitted that the Counter Petitioner is a young and energetic rowdy element and shows his muscle power by committing offences for petty reasons. As a result the people of the locality being afraid of the Counter Petitioner do not come forward to lodge any complaint against him. It is also stated that even witnesses don't come forward voluntarily to give evidence against him in the cases where he is the accused. In this connection, the Petitioner had stated that the following criminal cases as registered against the Counter Petitioner.
  - 1. Cr.No. 125/2019 under sections 341, 294 (b), 506 (ii) IPC r/w 34 IPC, dated 03-10-2019 Pending Trial.
  - 2. Cr.No. 127/2019 under sections 294 (b), 324, 506 (ii) IPC r/w 34 IPC, dated 05-10-2019 Pending Trial.
  - 3. Cr.No. 11/2020 under sections 294 (b), 324, 506 (ii) IPC r/w 34 IPC, dated 17-01-2020 Pending Trial.
  - 4. Cr.No. 41/2020 under sections 294 (b), 324, 506 (ii) IPC, dated 26-02-2020 Pending Trial.
  - 5. Cr.No. 528/2020 under sections 34 B(IX) and 34 E(I) of PP Act, dated 13-12-2020 Pending Trial.
  - Cr.No. 536/2020 under sections 143, 144, 294 (b), 324, 307 IPC r/w 149 IPC, dated 29-12-2020 Pending Trial.
  - 7. Cr.No. 189/2021 under sections 399, 402 IPC, dated 31-10-2021.
- 4. It is also stated in the I.R. that the Station House Officer has received reliable information that the Counter Petitioner is very active notorious rowdy element and has become a source of terror among the public. The Petitioner further stated that the Counter Petitioner was a habitual offender and involved in many hurt cases along with his associates. Further stated that he intentionally engaged persons by hire and insists them to create problems with their opposite groups and therefore, his criminal activities cannot be prevented by invoking the mere security proceedings under the Cr.P.C.

- 5. Hence, the Sub-Inspector of Police, Mudaliarpet Police Station has prayed to invoke provisions under 144 Cr.P.C against the Counter Petitioner do not to enter into the jurisdiction of this Court, for a period of two months as to prevent danger to the human life and properties, and disturbance to the public tranquility and order;
- 6. The proceeding was started by affording an opportunity to the Counter Petitioner to show cause against the petition filed by the Petitioner. A notice was served to both the parties on 21-10-2021 to appear for the hearing on 09-11-2021, 02-12-2021 and 16-12-2021. It was instructed to serve the notice to the Counter Petitioner through the Station House Officer, Mudaliarpet Police Station, Puducherry. The notice was received by the Counter Petitioner.
- 7. On 16-12-2021, the Station House Officer represented by Thiru C. Ilavarasan, Sub-Inspector of Police, Mudaliarpet Police Station, Puducherry and the Counter Petitioner were present.
- 8. I have heard both the sides and carefully gone through all the available records in file placed by the Petitioner. In the Police information report/petition, it is stated that the activities of the Counter Petitioner is in such a manner that he may cause breach of peace and create a problem of law and order, and public tranquility. He has involved in crimes such as assault, unlawful activities and disturbance to the public peace and order. There are 7 criminal cases were registered against him in the Mudaliarpet Police Station.
- 9. Upon hearing both sides and on perusal of the records submitted by the Petitioner, I am of the opinion that if, the Counter Petitioner is allowed to reside within the limits of my jurisdiction, the Counter Petitioner will continue to indulge in and also motivate serious offences like assault, annoyance, damages to public properties, *etc.*, and thereby become a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C., is invoked to take action against the Counter Petitioner to prevent harm to life and properties of citizens and uphold public peace and order.
- 10. Hence, I, M. Kandasamy, do hereby in the capacity of Subdivisional Magistrate (North), Puducherry, in exercise of the powers conferred under section 144(1) of the Code of Criminal Procedure, pass this order and prohibit the Counter Petitioner Thiru Pugazh (21), son of Ezhumalai, a resident of No. 48, Velrampet, Erikarai Street, Mudaliarpet, Puducherry, from entering into the region under the jurisdiction of the Subdivisional Magistrate Court (North), for a period of two months from the date of this order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry. However, the Counter Petitioner may represent against this order before the undersigned by post or by Counsel.

The facts which led up to the petition are briefly as follows: The case submitted by the Sub-Inspector of Police, Mudaliarpet Police Station, Puducherry, with the recommendation of Superintendent of Police (South), Puducherry, vide I.R. No. 159/2021, under section 144 of Cr.P.C, dated 29-09-2021. Therein, it has been stated that the Counter Petitioner have involved in crime such as hurt and disturbance to the public tranquility and order. The Counter Petitioner has created panic in the minds of local inhabitants and the business people in the city limits. It is also stated that he is leading lavish life with the money earned through extortion. The Petitioner has also submitted that the Counter Petitioner is a young and energetic rowdy element and shows his muscle power by committing offences for petty reasons. As a result the people of the locality being afraid of the Counter Petitioner do not come forward to lodge any complaint against him. It is also stated that even witnesses don't come forward voluntarily to give evidence against him in the cases where he is the accused. In this connection, the Petitioner had stated that the following criminal cases as registered against the Counter Petitioner.

- 7. On 16-12-2021, the Station House Officer represented by Thiru C. Ilavarasan, Sub-Inspector of Police, Mudaliarpet Police Station, Puducherry and the Counter Petitioner were present.
- 8. I have heard both the sides and carefully gone through all the available records in file placed by the Petitioner. In the Police information report/petition, it is stated that the activities of the Counter Petitioner is in such a manner that he may cause breach of peace and create a problem of law and order, and public tranquility. He has involved in crimes such as assault, unlawful activities and disturbance to the public peace and order. There is one criminal cases were registered against him in the Mudaliarpet Police Station.
- 9. This petition along with case sheet is filed by the Sub-Inspector of Police, Lawspet Police Station, Puducherry, praying to pass order under section 144 of Cr.P.C., against the Counter Petitioner to prevent imminent danger to human lives and properties, and disturbance to the public tranquility and order, in the jurisdiction of this Court.

- 2. The Counter Petitioner is Thiru Nivash (25), son of Yuvaraj a resident of No. 144, Edayanchavady Road, Karuvadikuppam, Lawspet, Puducherry.
- 3. The facts which led up to the petition are briefly as follows: The case referred by the Sub-Inspector of Police, Lawspet Police Station, Puducherry, with the recommendation of the Superintendent of Police (North), Puducherry vide I.R.No. 122/2021 under section 144 of Cr.P.C., dated 04-10-2021. Therein, it has been stated that the Counter Petitioner has formed a gang of rowdies and bent upon indulging in crime such as murder, attempt to murder, violence, intimidation, assault, disturbance to the public tranquility and order. The Counter Petitioner has created panic in the minds of local inhabitants and the business people in the Lawspet Police Station limits, Puducherry. As a result, the people of the locality being afraid

of the Counter Petitioner do not come forward to lodge any complaint against him. It is also stated that even witnesses don't come forward voluntarily to give evidence against him in the cases where he is the accused. In this connection, the Petitioner had stated that the following criminal cases as registered against the Counter Petitioner.

- Cr.No. 88/2019, under sections 120(b), 148, 341, 324, 307, 302, 109 IPC r/w 149 IPC and 3 of Explosive Substances Act, 1908 of Muthialpet Police Station, Puducherry – Pending Trial.
- 4. It is further stated in the I.R. that the Counter Petitioner is having close contact with other rowdy elements, *viz.*, Chozhan @ Chozharajan, who is also a history sheet holder of Lawspet Police Station, Puducherry and hatching plans to indulge in unlawful activities in the Lawspet area and extort money by threatening. And also, he is a young and very active notorious rowdy element and therefore his criminal activities cannot be prevented by invoking the mere security proceedings under the Cr.P.C.

- 6. The proceeding was started by affording an opportunity to the Counter Petitioner to show cause against the petition filed by the Petitioner. A notice was served to both the parties on 06-12-2021 to appear for the hearing on 14-12-2021 at 10.00 a.m. It was instructed to serve the notice to the Counter Petitioner through the Station House Officer, Lawspet Police Station, Puducherry. The notice for the Counter Petitioner was received by his mother Tmt. Manju. The Service was held sufficient for the Counter Petitioner.
- 7. On 14-12-2021, the Station House Officer, represented by Thiru Kumar, Assistant Sub-Inspector of Police, Lawspet Police Station, Puducherry, was present. The Counter Petitioner has failed to appear before the Court on hearing date.
- 8. I have heard the Petitioner and carefully gone through all the available records placed before me. In the Police Information Report/Petition, it is stated that the activities of the Counter Petitioner is in such a manner that he may cause breach of peace and create a problem of law and order, and public tranquility. He has involved in crimes such as murder and disturbance to the public peace and order. There is one criminal case was registered against him in Muthialpet Police Station.
- 9. On perusal of the records submitted by the Petitioner and the recommendation of the Superintendent of Police (North), I am of the opinion that if, the Counter Petitioner is allowed to reside within the limits of my jurisdiction, the Counter Petitioner will continue to indulge in and also motivate serious offences

like murder, obstructions, annoyance, damages to public and private properties, *etc.*, and thereby become a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C., is invoked to take action against the Counter Petitioner to prevent harm to life and properties of citizens and uphold public peace and order;

Therein, it has been stated that the Counter Petitioner have indulging in crime such as hurt, unlawful activities, disturbance to the public tranquility and order. The Petitioner has also submitted that the Counter Petitioner is a young and energetic rowdy element and shows his muscle power by committing offences for petty reasons. He is very active and therefore his criminal activities cannot be prevented by invoking the mere security proceedings under the Cr.P.C. In this connection, the Petitioner had stated that the following criminal cases as registered against the Counter Petitioner.

It is also stated in the additional report, dated 14-12-2021 that the Station House Officer has received reliable information that the Counter Petitioner involved in a sensational Depulan murder case and further the Counter Petitioner and his associates were designed to take revenge by killing of deceased Depulan family members/associates who lodged complaint against him and also designed to eliminate witnesses in the said case.

- 5. The Petitioner further submitted that if, the Counter Petitioner is allowed to reside in the village, it is apprehended that he would continue to indulge in serious offences like hurt, criminal intimidation, assault, obstructions and annoyance, danger to the human life and properties, and thereby emerged as a perennial source of threat to the community and disturb public peace and tranquility. Hence, the Station House Officer, Odiansalai Police Station, has prayed to invoke provisions under section 144 of Cr.P.C., against the Counter Petitioner do not to enter into the jurisdiction of this Court, for a period of two months as to prevent danger to the human life and properties, and disturbance to the public tranquility and order.
- 6. The proceeding was started by affording an opportunity to the Counter Petitioner to show cause against the petition filed by the Petitioner. A notice was served to both the parties on 24-11-2021 to appear for the hearing on 30-11-2021 and further hearings on 07-12-2021 and 14-12-2021. It was instructed to serve the notice to the Counter Petitioner through the Station House Officer, Odiansalai Police Station, Puducherry. The notice was received by the Counter Petitioner.
- 7. On 14-12-2021, the Station House Officer by Thiru B.M. Manoj, Inspector of Ploice, Odiansalai Police Station, Puducherry and the Counter Petitioner was present.
- 8. I have heard both the sides and carefully gone through all the available records in file placed by the Petitioner. In the Police information report/petition, it is stated that the activities of the Counter Petitioner is in such a manner that he may cause breach of peace and create a problem of law and order, and public tranquility. He has involved in crimes such as hurt and disturbance to the public peace and order. There are 12 criminal cases were registered against him in various Police Stations. I have also heard the oral submissions of the Counter Petitioner. The Counter Petitioner has stated that the Petitioner has filed this false case with an ulterior motive.

Upon hearing both sides and on perusal of the records submitted by the Petitioner, I am of the opinion that if, the Counter Petitioner is allowed to reside within the limits of my jurisdiction, the Counter Petitioner will continue to indulge in and also motivate serious offences like murder, assault, damages to public properties, *etc.*, and thereby become a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C., is invoked to take action against the Counter Petitioner to prevent harm to life and properties of citizens and uphold public peace and order.
- 10. Hence, I, M. Kandasamy, do hereby, in the capacity of Subdivisional Magistrate (North), Puducherry, in exercise of the powers conferred under section 144(1) of the Code of Criminal Procedure, pass this order and prohibit the Counter Petitioner Thiru Gnanavel (33), s/o. Munusamy, a resident of No. 53, Maravady Street, Kurusukuppam, Puducherry, from entering into the region under the jurisdiction of the Subdivisional Magistrate Court (North) for a period of two months from the date of this order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry. However, the Counter Petitioner may represent against this order before the undersigned by post or by Counsel.

### ORDER

(Under Section 144 of Cr. P.C.)

. Counter Petitioner

This petition along with case sheet is filed by Station House Officer, Muthialpet Police Station, Puducherry, praying to pass orders under section 144 of Cr.P.C., against Thiru Gnanasegar (31) to prevent imminent danger to human lives and properties and disturbance to the public tranquility and order, in the jurisdiction of this Court.

- 2. The Counter Petitioner is Thiru Gnanasegar (31), s/o. Munusamy, a resident of No. 53, Maravady Street, Kurusukuppam, Puducherry.
- 3. The facts which led up to the petition are briefly as follows: The case is submitted by the Station House Officer, Muthialpet Police Station through the Superintendent of Police (East), Puducherry vide I.R.No. 75/2021, under section 144 of Cr.P.C., dated 10-10-2021. Therein, it has been stated that the Counter Petitioner has formed a gang of rowdies and bent upon indulging in crime such as disturbance to the public tranquility and order by showing deadly weapons. The Counter Petitioner has created panic in the minds of local inhabitants and the business people in the Muthialpet Police Station limits, Puducherry. It is also stated that he is leading lavish life with the money earned from the public and business people by threatening. As a result, the people of the locality, being afraid of the Counter Petitioner, do not come forward to lodge any complaint against him. In this connection, the Petitioner had stated that the following criminal cases were registered against the Counter Petitioner.
  - 1. Cr. No. 33/12, under sections 147, 427, 324, 506(ii) r/w 149 IPC, dated 06-02-2012 of Muthialpet Police Station, Puducherry.
  - 2. Cr. No. 78/15, under sections 294 (b), 323, 324, 427, 506(ii) IPC r/w 34 IPC, dated 09-08-2015 of Muthialpet Police Station, Puducherry.
  - 3. Cr. No. 40/16, under sections 143, 341 IPC r/w 149 IPC, dated 05-05-2016 of Muthialpet Police Station, Puducherry.
  - 4. Cr. No. 44/16, under sections 341, 294(b), 323, 506(i) IPC r/w 34 IPC, dated 12-05-2016 of Muthialpet Police Station, Puducherry.
  - 5. Cr. No. 107/17, under sections 147, 148, 307 IPC r/w 149 IPC of Muthialpet Police Station, Puducherry.
  - 6. Cr. No. 132/2017, under sections 294(b), 323, 324, 506(ii) IPC r/w 34 IPC, dated 25-11-2017 of Muthialpet Police Station, Puducherry.
  - 7. Cr. No. 37/2018, under sections 147, 148, 302 IPC r/w 149 IPC, dated 06-03-2018 of Grand Bazaar Police Station, Puducherry.
  - 8. Cr. No. 94/2019, under sections 120(B), 148, 341, 302, 109 r/w 149 IPC, dated 08-12-2019 of Muthialpet Police Station, Puducherry.
- 4. It is also stated in the I.R. that the Station House Officer has received reliable information that the Counter Petitioner is desperate and is in dire need of money to maintain his rowdy gang to meet out in case trials and daily expenses.

The Petitioner further stated that the Counter Petitioner is not a law abiding person and therefore, his criminal activities cannot be prevented by invoking the mere security proceedings under the Cr.P.C.

- 5. The Petitioner further stated that if, the Counter Petitioner is allowed to reside in Muthialpet limits, it is apprehended that he would continue to indulge in serious offences like attempt to murder, hurt, damages, assault and thereby emerged as a perennial source of threat to the community and disturb public peace and order. Hence, the Station House Officer, Muthialpet Police Station has prayed to invoke provisions under section 144 Cr.P.C. against the Counter Petitioner to not to enter into the jurisdiction of this Court for a period of two months as to prevent danger to the human life and properties and disturbance to the public tranquility and order.
- 6. The proceeding was started by affording an opportunity to the Counter Petitioner to show cause against the petition filed by the Petitioner. A notice was served to both the parties on 08-12-2021 to appear for the hearing on 15-12-2021 at 10.00 a.m. It was instructed to serve the notice to the Counter Petitioner through the Station House Officer, Muthialpet Police Station, Puducherry. The notice for the Counter Petitioner was received by his wife Tmt. Subitha. The service was held sufficient for the Counter Petitioner.
- 7. On 15-12-2021, the Petitioner Thiru G. Kalaiarasan, Sub-Inspector of Police, Muthialpet Police Station, Puducherry and the Counter Petitioner were present.
- 8. I have heard both the sides and carefully gone through all the available records in file placed by the Petitioner. In the Police information report/petition, it is stated that the activities of Thiru Gnanasegar is in such a manner that he may cause breach of peace and create a problem of law and order and public tranquility. He has involved in crimes such as murder, assault, unlawful activities and disturbance to the public peace and order. There are 8 criminal cases were registered against him in various Police Stations. I have also heard the oral submissions of the Counter Petitioner. The Counter Petitioner has stated that the Petitioner has filed this false case with an ulterior motive.
- 9. Upon hearing both sides and on perusal of the records submitted by the Petitioner, I am of the opinion that if, the Counter Petitioner is allowed to reside within the limits of my jurisdiction, the Counter Petitioner will continue to indulge in and also motivate serious offences like murder, assault, damages to public properties, *etc.*, and thereby become a perennial source of threat to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C. is invoked to take action against the Counter Petitioner to prevent harm to life and properties of citizens and uphold public peace and order.
