

And whereas, the Station House Officer, Sedarapet Police Station, Puducherry, has filed a case against you *vide* IR.No. 61/2021 under section 144 of Cr. P.C., dated 02-12-2021. Station House Officer, Sedarapet Police Station, Puducherry, that you are indulging in crime such as attempt to murder, Arms Act, theft case and disturbance to the public tranquility and order, and you have created panic in the minds of local inhabitants. It is also stated that you have become a source of terror among the public. As a result the people of the locality being afraid of you and do not come forward to lodge any complaint against you. It is also stated that even witnesses don't come forward voluntarily to give evidence against you in the cases where you are the accused;

And whereas, the Station House Officer, Sedarapet Police Station, Puducherry, further submitted that if, you are allowed to reside in Subdivisional Magistrate (South) Jurisdiction limits, it is apprehended that you would continue to indulge in serious offences like murder, Explosive Substances Act, Arms Act, theft and disturbance to the public tranquility and order, *etc.*, and thereby emerged as a perennial source of threat to the community and disturb public peace and order;

And whereas, summons were served for your appearance on 17-12-2021 and 07-01-2022 to file your explanation/objection as to why the Subdivisional Magistrate (South), Villianur, Puducherry, should not order to prevent you from entering into the south region under section 144 (3) of Cr.P.C., and you failed to appear before this Court and hence, the case is decided *ex parte* under section 144(2) of Cr.P.C., in the view of urgency of the matter;

And whereas, based on the report laid before me, I am of the opinion that if, you are allowed to reside within the limits of this jurisdiction, you will continue to indulge in and also motivate serious offences and disturbance to the public tranquility and order, *etc.*, and thereby become a perennial source of threat

to the community and disturb public peace and order. Such situations cannot be handled effectively by taking recourse to usual procedures contemplated by law and hence, it is necessary that special provision under section 144 of Cr.P.C., is invoked to cake action against you to prevent harm to life and properties of citizens and uphold public peace and order; your presence is a threat to public tranquility in Puducherry District and therefore, an immediate action is required for curtailing your illegal activities in the locality;

Now, therefore, based on the reasons stated above, I, Rishita Gupta, I.A.S., Subdivisional Magistrate (South), Puducherry, in exercise of powers conferred under Code of Criminal Procedure, do hereby prohibit you under section 144 of Cr.P.C., from entering into the Subdivisional Magistrate Court (South), Jurisdiction for two months from the date of this order or till any further orders are passed by the Competent Authority revoking this prohibition as per law, whichever is earlier except when you are summoned to attend the cases in any of the Courts in Puducherry. However, you may appear either in person or by pleader before the undersigned to represent against the order.
