NOTIFICATION

The Hon'ble Lieutenant-Governor, Puducherry, is pleased to enhance the financial assistance granted to the Awardees of Tamilmamani, Malayala Ratna, Telugu Ratna and Pudevai Kalaimamani according to their age from ₹ 1,650 to ₹ 2,150, ₹ 2,200 to ₹ 2,700 and ₹ 3,250 to ₹ 3,750 under the Scheme of "the Grant of Financial Assistance to Awardees of Tamilmamani, Malayala Ratna, Telugu Ratna and Pudevai Kalaimamani in the Union territory of Puducherry" and for the said purpose, hereby makes further amendment of order notified in G.O. Ms. No. 85, dated 19-07-2006 of the Chief Secretariat (Art and Culture) and published in the Gazette of Puducherry, Extraordinary Part-I, No. 120, dated 21-07-2006 (hereinafter referred to as the said Scheme) as follows:

AMENDMENT

In para 4 of the said Scheme for the words, figures and brackets, the following shall be substituted, namely:-

“4. Nature of Assistance:- Financial assistance to the Awardees of Tamilmamani, Malayala Ratna, Telugu Ratna and Pudukai Kalaimamani in the Union territory of Puducherry aged up to 59 shall be paid ₹ 2,150 (Rupees two thousand one hundred and fifty only) per month, aged between 60 and 79 years shall be paid ₹ 2,700 (Rupees two thousand and seven hundred only) per month and aged 80 years and above shall be paid ₹ 3,750 (Rupees three thousand seven hundred and fifty only) per month”.

2. The above amendment shall come into force with effect from the beginning of the next financial year *i.e.*, FY-2022-23.

3. This issues with the concurrence of the Finance Department *vide* their I.D. Note No. 4030/FC/FD/F4/A4/2021-22, dated 22-12-2021.
