(Waqf)/ T10/2009, dated 29th December 2009 of the Department of Hindu Religious Institutions and Waqf, Government of Puducherry and published in Part-II, Extraordinary Gazette of Puducherry, in No. 1, dated 6th January, 2010, namely:-

AMENDMENT

1. Short title, extent and commencement.— (1) This Scheme may be called "Grant of Educational Scholarship, ad hoc Grant, etc., to the Minority Muslim Students (Amendment), 2021".

(2) It shall apply to the students of Union territory of Puducherry studying in approved educational Schemes in recognised educational Institutions in India.

(3) It shall come into force with effect from the date of this Notification.

2. Amendment of Rule 4.— In the "Scheme for the Grant of Educational Scholarship, ad hoc Grant, etc., to the Minority Muslim Students in the Union territory of Puducherry" in rule 4(1), "The annual income of the parents from all sources should not exceed ₹ 60,000" for the existing figure, the following shall be substituted, namely-"₹ 2,00,000".
